**REPORT ON: SCOTTISH CLIMATE CHANGE DECLARATION**  
**REPORT BY: ASSISTANT CHIEF EXECUTIVE (COMMUNITY PLANNING)**

**1. PURPOSE OF REPORT**

To recommend that the Council signs up to the Scottish Climate Change Declaration and participates in the launch of the Declaration.

**2. RECOMMENDATIONS**

It is recommended that the Council should:

- i) sign up to the Scottish Climate Change Declaration as set out in Appendix One to this report
- ii) participate, along with the Scottish Executive and other local authorities, in a public launch of the Declaration which is likely to take place in the near future.
- iii) set up a short term working group chaired by the Assistant Chief Executive (Community Planning) to draw up a Climate Change Action Plan.

**3. FINANCIAL IMPLICATIONS**

Staff time will be required to produce and monitor a 'climate change action plan', but the cost of the staff time will be contained within existing budgets of the departments concerned.

**4. SUSTAINABILITY POLICY IMPLICATIONS**

- a) Climate change is widely recognised as the most serious environmental threat we currently face. Through its complex nature it influences every Sustainability Policy principle, from forward planning of new buildings and infrastructure, alleviating flooding, maintaining air quality and reducing CO<sub>2</sub> emissions, to the management of green spaces, waste and health of the environment. A Climate Change Action Plan will publicly demonstrate the Council's commitment to mitigating and adapting to the effects of climate change and contribute to improving our own environmental performance.
- b) Strategic Environmental Assessment - the subject of the report would require an action plan to be drawn up and therefore an SEA screening has been carried out. This indicates that the plan should not require a full Environmental Assessment due to the nature of the plan to be prepared. The actions and initiatives to be contained in the plan will be collated from existing Council strategies, plans and programmes which themselves escape SEA requirements as set out in the legislation. If, in the future, the action plan is to change or there are likely to be significant changes to the other Council strategies, plans and programmes, then an SEA may be required. This has been raised nationally with the Scottish Executive and guidance is awaited.

## 6. BACKGROUND

6.1 The Scottish Climate Change Declaration has been produced by the Scottish Local Authority Climate Change Programme Development Group. Signing the declaration is seen as an opportunity to:

- highlight action to date and demonstrate the work that has already been done
- share success with others
- plan and declare future action
- build confidence across Scotland that steps are being taken to address climate change

6.2 The Declaration is set out in full in Appendix One to this report. In summary, it would commit the Council to:

- Produce and publicly declare a plan, with targets and time-scales, to achieve a significant reduction in greenhouse gas emissions from our own operations. This will include energy sourcing and use, travel and transportation, waste production and disposal, estate management, procurement of goods and services, and improved staff awareness.
- Ensure that greenhouse gas reduction and climate change adaptation measures are clearly incorporated into all of our new and existing strategies, plans and programmes, in line with sustainable development principles.
- Assess the risks and opportunities for our services and our communities of predicted climate change scenarios and impacts, and take action to adapt accordingly and in line with sustainable development principles.
- Encourage and work with all sectors in our local community to take action to adapt to the impact of climate change, to reduce their own greenhouse gas emissions and to make public their commitment to action.
- Monitor and publish an annual report on the progress of our climate change response, detailing targets set, actions taken, outcomes achieved and further actions required.

6.3 Much of this work is already underway in Dundee, through the Council's Sustainability Policy, existing Council strategies and plans, the work of individual departments and the involvement of Community Planning partners such as Dundee Sun City and Dundee Energy Efficiency and Advice Project. Although some staff resources will be required to develop and monitor a 'climate change action plan', guidance and support is available to assist with this. It is therefore recommended that Dundee City Council sign up to the Declaration.

6.4 It is anticipated that a Scotland-wide launch of the Declaration will be organised in the near future, involving the Scottish Executive and those local authorities which are signing up. This will form part of a programme of publicity, including a national TV advertising campaign promoting sustainable development, work on carbon proofing policy and publication of the Scottish Executive's energy strategy, as well as pursuing action following the publication of the Climate Change Strategy 'Changing Our Ways', which will seek to ensure that climate change is considered as part of the development of all policies throughout local government and elsewhere. It is recommended that the Council participate in the public launch of the Declaration.

6.5 A key aspect of the Council's commitment to the Declaration will be the development of a Climate Change Action Plan. It is recommended that a short term working group chaired by the Assistant Chief Executive (Community Planning) should be remitted to develop this plan.

### The Scottish Climate Change Declaration

We acknowledge that

- Evidence shows that climate change is occurring and that human activities are having a significant negative and potentially dangerous influence.

- Ensure that greenhouse gas reduction and climate change adaptation measures are clearly incorporated into all of our new and existing strategies, plans and programmes, in line with sustainable development principles.
- Assess the risks and opportunities for our services and our communities of predicted climate change scenarios and impacts, and take action to adapt accordingly and in line with sustainable development principles.
- Encourage and work with others in our local community to take action to adapt to the impact of climate change to reduce their own greenhouse gas emissions and to make public their commitment to action.
