#### 1.0 PURPOSE OF REPORT

1.1 To seek approval of the offer from specialist supplier Forbes and Company Signmakers, Dundee to undertake the manufacture and erection of Parks Information Boards at Balgay Cemetery, Balgay Hill, Victoria Park and Fairmuir Park.

#### 2.0 RECOMMENDATIONS

2.1 It is recommended that the committee approve the offer of £14,160.00 from Forbes and Company Signmakers, Dundee for the manufacture and erection of information boards at Balgay Hill, Victoria Park, and Fairmuir Park.

## 6.0 MAIN TEXT

The proposed signage to the entrance of the parks is designed to provide a welcoming, informative first impression to the parks and cemetery and encourages people to make better use of the facilities. This is seen as the third phase of a programme of works to make improvements to the city's parks.

There will also be space to promote events throughout the city's parks.

An offer was sought from a single nominated supplier who was the successful supplier in phase 2 of the parks improvement programme. By seeking a single supplier a consistent standard of design and workmanship will be achieved.
