1.0 **PURPOSE OF REPORT**

- 1.1 Under the Secure Tenants (Right to Repair) (Scotland) Regulations 1994 the City Council is required to maintain a list of contractors prepared to carry out qualifying repairs, this list to include the usual Contractor, which in the City Council's case is Dundee Contract Services.
- 1.2 The purpose of this report is to seek Committee approval for the inclusion on this list of interested contractors provided they are on the Council's select tender list and have submitted reasonable jobbing rates. The list will be maintained by the Director of Housing.

2.0 **RECOMMENDATIONS**

2.1 Inclusion of the six firms who expressed an interest on the list of contractors prepared to carry out qualifying repairs.

7.0 BACKGROUND

- 7.1 Under the Secure Tenants (Right to Repair) (Scotland) Regulations 1994, tenants of council houses have a right to have certain repairs, called "qualifying repairs", undertaken within a specified period. The qualifying repairs are listed in the Schedule of the Regulations and mainly relate to lack of heat or water and health and safety items. The maximum amount payable in respect of a single qualifying repair is £250.
- 7.2 Should the usual contractor, ie, Dundee Contract Services, fail to commence a qualifying repair within the time specified in the Schedule to the Regulations the tenant has the right to instruct another listed contractor to carry out the repair. On receipt of such an instruction the listed contractor will inform the Housing Department to obtain a copy of the relevant works order.

8.1 The Chief Executive, Depute Chief Executives (Finance and Support Services) and the Director of Housing have been consulted in the preparation of this report.
