1.0 PURPOSE OF REPORT

1.1 This report makes recommendations for the further allocation of Social Inclusion Partnership funding 1 and 2 for the financial year 2002/2003, and recommends a number of grants from the SIP 1 and 2 Small Grants Fund.

2.0 **RECOMMENDATIONS**

It is recommended that the Committee:

- 2.1 agrees the further allocation of Social Inclusion Partnership funding 2002/2003 as detailed in Section 6.
- 2.2 notes the Partnership's recommendations for the allocation of Social Inclusion Partnership 1 and 2 Drugs Misuse funding, as detailed in Section 8.
- 2.3 notes the Partnership's recommendation to transfer Social Inclusion Partnership 1 funding from Happyhillock Resource Base to Brooksbank Neighbourhood Centre, as detailed in Section 7.
- 2.4 agrees the award of Social Inclusion Partnership 1 and 2 Small Grants as detailed in Appendices C and D.

3.0 FINANCIAL IMPLICATIONS

3.1 SIP1 and SIP2 Expenditure 2002/2003 (Appendix A).

3.2 Provision has been made in the Social Inclusion Partnership Fund section of the Neighbourhood Resources and Development Department Revenue budget 2002/2003 for the above expenditure.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 There is a close relationship between Local Agenda 21 targets and the focus of the Social Inclusion Partnership programme. The revenue expenditure proposals contained within this report are intended to meet local needs. The proposals also seek to assist with implementation of the Dundee Partnership's Community Regeneration Strategy. As such, the measures contained in this report will impact on numerous Agenda 21 targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those areas which fall within the most disadvantaged 10% of enumeration districts at the time of the 1991 Census. The funding made available is intended to have the effect of equalling opportunities.

6.0 SOCIAL INCLUSION PARTNERSHIP 1 - ALLOCATION OF RESOURCES 2002/2003

6.1 Kirkton Security and Environmental Initiative (Phases 3 and 4).

Report 505-2002 (NRD Committee 10 June 2002) recommended that consideration of this proposal be deferred in order to complete cost assessment and consultation. A provisional allocation of £31,000 was ring-fenced pending the Partnership's final recommendation.

Cost assessment and consultation with the Housing Department has now been completed, and the Partnership's recommended funding allocation for the project is as follows:

The Housing Department will also be exploring other possible sources of funding for this project.

6.2 Hilltown ICT Support (Ring-Fenced Allocation).

Report 505-2002 (NRD Committee 10 June 2002) recommended a ring-fenced allocation of £15,695 for Hilltown ICT Support, pending the development of a proposal for use of this funding by Maxwelltown Information Centre.

Following consideration of the proposal the Board of Maxwelltown Information Centre has notified the Grants Sub Group that the Board's current priority is to identify long term funding for the Centre, given the end of its current Social Inclusion Partnership 1 funding on 31 March 2003. For this reason, the Board does not feel that it is in a position to lead on the development of the ICT Support proposal.

ICT Support is being delivered in Hilltown through the Empowering Communities Initiative and the Community Capacity Project, therefore the Grants Sub Group has recommended that the ring-fenced allocation of £15,695 (2002-2003) be returned to the Social Inclusion Partnership 1 revenue budget and re-allocated to other projects during 2002/2003.

7.0 HAPPYHILLOCK RESOURCE BASE TRANSFER OF SOCIAL INCLUSION PARTNERSHIP 1 FUNDING TO BROOKSBANK NEIGHBOURHOOD CENTRE

Report 508-2002 (NRD Committee 10 June 2002) outlined proposals for the transfer of Brooksbank Neighbourhood Centre lease to the Dundee Anti Poverty Forum and the Money Advice Support Team. These projects were previously based at Happyhillock Resource Base.

Property costs for Happyhillock Resource Base are currently met by Social Inclusion Partnership 1 funding (£23,118 2002/2003), and this approval is in place until 31 March 2004.

Given the re-location of projects to Brooksbank Neighbourhood Centre it is recommended that the Social Inclusion Partnership 1 funding currently allocated to Happyhillock Resource Base be transferred to Brooksbank for the period to 31 March 2004. This will ensure that property costs at Brooksbank are met in full without detriment to the new lease holders.

Any further allocations of funding for property costs will be subject to an extension application during 2003 by the lease holders.

8.0 DRUGS MISUSE PROGRAMME (PHASE 2) 2002/2004

8.1 The Scottish Executive has awarded the following funding to Social Inclusion Partnerships 1 and 2 as part of the Drugs Misuse Programme 2002/2004.

Appendix B gives details of proposals that are recommended for funding. A number of these proposals have been extended from Phase 1 of the Programme that was implemented during 2000/2002. New proposals have been assessed by the Drug and Alcohol Action Team (DAAT) who engaged an external consultant to carry out this work.

- 8.2 The following proposals have not been recommended for funding at this stage:
 - NCH Prevention Work with Families
 - Ardler Information Point
 - Kirkton Drug Related Research
 - West End Youth Work

Reasons for not approving these projects are given in Appendix B.

8.3 A balance of funding is still available for this programme in financial years 2002/2003 and 2003/2004. Further proposals will be reported to NRD Committee at a later date.

9.1 Awards totalling £1,460 are recommended in this report.

10.0 SOCIAL INCLUSION PARTNERSHIP 2 SMALL GRANTS FUND (APPENDIX D)

10.1 Awards totalling £6,052 are recommended in this report.

11.0 CONSULTATION

- 11.1 Consultation has taken place with the Chief Executive, the Director of Finance, the Director of Support Services, the Director of Planning and Transportation, the Director of Economic Development, the Director of Education, the Director of Social Work, the Director of Leisure and Parks, the Director of Housing.
- 11.2 Partnership agencies, community representatives and voluntary sector representatives have also been consulted and involved in the assessment of applications, and the formation of recommendations contained in this report.
- 11.3 The recommendations are based on targets set by Communities Scotland and the Dundee Partnership targets. Area regeneration strategies for Kirkton, Ardler, Mid Craigie/Linlathen and Hilltown have also been considered in forming the recommendations contained within Appendix B of this report. These local area strategies take into account the views expressed in a variety of consultative meetings and events within each local community.
