#### 1.0 PURPOSE OF REPORT

1.1 This report is to approve tenders for Outdoor Access Improvement Works targeted at the Green Circular route, the City's parks and Broughty Ferry Dunes.

## 2.0 RECOMMENDATIONS

2.1 Approval is recommended for the acceptance of the quotations submitted by T & N Gilmartin (Contractors) Ltd for Green Circular Improvements and Cycle Parking in the amount of £24,782 and Willow and Woods Ltd for Broughty Ferry Dunes Access Improvements in the amount of £1,322.

### 3.0 FINANCIAL IMPLICATIONS

3.1 This expenditure totalling £26,104 can be met from the Leisure and Communities Department's 2008/09 Capital Budget of which £50,000 is targeted towards Outdoor Access Improvements, £45,000 for Green Circular Improvements and £5,000 for Broughty Ferry Dunes Access.

# 4.0 MAIN TEXT

- 4.1 Reference is made to Article IV of the Leisure and Arts Committee of 15 March 2004, which allows for ongoing improvements to the Green Circular and improving access to it, and to Article IV of the Policy and Resources Committee of 15 August 2005 when approval was given for Dundee's Outdoor Access Strategy. The proposed improvement works are to be carried out in line with this strategy.
- 4.2 A recent audit of the Green Circular route highlighted a number of areas where upgrading work is required to maintain the standard of the route. This area in most need of work this year is the section in the north of Camperdown Country Park, where the surface of the path has become badly eroded. Proposed works to bring this section of the route up to standard will involve resurfacing this path with whindust.
- 4.3 To encourage more people to cycle more often for environmental and health benefits it is recognised that facilities need to be in place to support this. It has been noted that many of the city's parks do not have cycle parking facilities which would encourage people to cycle to the parks to spend time there. Sites for cycle parking will include Dawson Park, Stobsmuir Park, Fairmuir Park, Broughty Ferry Local Nature Reserve, Caird Park, Lochee Park, Victoria Park, Balgay Hill and Templeton Woods Visitor Centre.
- 4.5 It is intended to carry out improvements to access along the dunes at Broughty Ferry in collaboration with Broughty Ferry Environmental Project. This will include the creation of a pathway through the dunes marked out by willow weave fencing. A small area will be used as a trial phase with a view to extending this along the dune system and

replacing the existing dune fencing.

4.6 Tender documentation was sent to eight companies and seven were returned as detailed in Appendix 1.

#### 5.0 POLICY IMPLICATIONS

This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.

There are no major issues.

### 6.0 CONSULTATION
