1.0 PURPOSE OF REPORT

1,1 To seek approval for discontinuation of the discretionary small skip service and replace with alternative arrangements from the first quarter of financial year 2025/26.

2.0 **RECOMMENDATIONS**

2.1 The Committee is asked to approve the withdrawal of the small skip service and to remit the Executive Director of Neighbourhood Services to make the necessary changes to provide alternative arrangements to existing customers and within Environment service operations.

3.0 FINANCIAL IMPLICATIONS

3.1 It is estimated that the withdrawal of the small skip service will generate an annual revenue saving of £48,000 per annum from 2025/26 onwards.

4.0 BACKGROUND

- 4.1 Waste Services provide a skip and container service for businesses and council service areas within Dundee. The service includes the following users: -
 - Commercial contracts (regular customers)
 - Commercial requests on an ad hoc basis
 - Dundee City Council users (i.e. allotments and cemeteries)
 - Recycling Centre requirements

Two types of vehicles operate on a day-to-day basis; large hook lift skip vehicles, primarily serving the household waste recycling centres and businesses with large volumes of waste using 20, 30 and 40 cubic yard containers, and a small chain lift skip vehicle servicing smaller 8 and 14 cubic yard containers.

- 4.2 Although the large skip vehicles would need to continue to provide a collection service for the household waste recycling centres and internal movements of waste, the small skip service (8 and 14 cubic yard capacity) has now dropped to a level which is no longer considered sustainable. It is therefore proposed to discontinue the small skip service and provide existing internal/external customers detailed within 4.1 with appropriate alternative provision, including larger skips and waste container arrangements. An analysis has been undertaken to determine the alternative service provision required at each location according to client and specific site requirements.
- 4.3 This proposal was contained within the budget consultation exercise 2025/26. A summary of the key responses is provided in Appendix 1.

5.0 REVISIONS TO SERVICE PROVISION AND ASSOCIATED SAVINGS

- 5.1 At the recycling centres and cemeteries, it is proposed to replace small skips with large skips or Eurobins. Existing commercial customers will be offered large skips or a commercial bin service. For the allotments, alternative service provision will be provided which would include composters for on-site recycling and either euro bins or wheeled bins for green waste and general waste collection. Provision of composters at allotment sites will encourage on-site composting. This will improve the range of options for waste management at allotment sites. Prior to the implementation of these changes, there will be engagement with customers of both directly managed and leased allotments sites in relation to the alternative service provision that will be put in place and the associated timescales.
- 5.2 The withdrawal of the small skip service will generate an annual revenue saving of £48,000. This will be achieved through a combination of a reduction in transport costs of £37,000 and staffing costs of £11,000.

6.0 POLICY IMPLICATIONS

This report has been subject to an Integrated Impact Assessment to identify impacts on Equality & Diversity, Fairness & Poverty, Environment and Corporate Risk. An impact, positive or negative, on one or more of these issues was identified. The appropriate senior manager has checked and agreed with this assessment. A copy of the Integrated Impact Assessment showing the impacts and accompanying benefits of/ mitigating factors for them is included as an Appendix to this report.

Budget Consultation 2025/26 - Small Skip Service

Respondents' opinions varied widely, with some supporting the change and others expressing concerns about its potential impact.

- There was general support for change with several respondents supporting the proposal, citing cost savings and the availability of private skip services as reasons to proceed with the change.
- Many respondents are worried that reducing or removing the small skip service will lead to increased fly-tipping which could negatively impact the environment and the appearance of the city.
- Others highlighted that not everyone has access to transportation, making it difficult for them to dispose of large items without the small skip service.
- Many respondents mentioned that issues with waste management in general would only be exacerbated if this service was withdrawn.
- Several were unaware of the small skip service, which was felt indicated a need for better communication and marketing of the service.
- Some respondents suggested better management of existing bins, more frequent collections, and the introduction of larger communal bins.
- Others proposed the idea of implementing a system like wider European models, where people take their rubbish to central points.
- There were also suggestions to reanalyse the areas with high usage to be more targeted and efficient.
