1.0 PURPOSE OF REPORT

1.1 The Report brings forward proposals for the further allocation of SIPS revenue funding and awards from the Small Grants Programme 2000/2001.

2.0 RECOMMENDATIONS

- 2.3 Agrees the award of SIP2 Small Revenue Grants, as set out in Appendix D.

3.0 FINANCIAL IMPLICATIONS

3.1 The proposed allocation of SIP1 and 2 revenue funding, as detailed in Appendix B, and Small Revenue Grants as detailed in Appendices C and D, can be contained within the Social Inclusion Partnership Fund Section of the Neighbourhood Resources and Development Department Revenue Budget 2000/2001.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 Priority has been given to revenue expenditure that is likely to be of benefit to the environment in the target areas. Also, meeting local needs is a central focus of the strategy for community regeneration and, as such, these measures will impact on numerous Agenda 21 targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those which fall within the most disadvantaged 10% of enumeration districts at the time of the last Census. The funding made available for the Social Inclusion Partnerships is intended to have the effect of equalling opportunities.

6.0 SIP1 AND SIP2 – ALLOCATION OF RESOURCES 2000/2001

- 6.1 Following finalisation of revenue budget allocations for existing projects which are funded through the Social Inclusion Partnership Fund, there is a balance of revenue funding available for allocation up to 31 March 2001 (SIP1 £66,449, SIP2 £21,139).
- In order that this remaining balance of revenue funding be targeted at designated SIP areas, the Grants Sub Group of the Dundee Partnership Community Regeneration Group agreed that existing projects should be invited to submit proposals for funding. Notification of the available balance was also given to Neighbourhood Development Group Chairs, Neighbourhood Development Officers and SIP Workers in order that other initiatives/proposals for SIP areas could be considered.
- 6.3 The closing date for the submission of proposals was 1 September 2000.

At total of 19 proposals were received by the closing date. All proposals were assessed by the SIP Implementation Team, and the Grants Sub Group of the Dundee Partnership. Local Community Co-ordinating Groups comprising local community reps also gave their views on each proposal.

6.4 As a result of the assessment process, the following proposals have not been recommended for funding:

- Kirkton Central Core Feasibility Study (Planning and Transportation Department; application withdrawn)
- Macdonald Street/Rosebank Street, site clear-up (Housing Department)

- Charleston Youth Library (Charleston Neighbourhood Centre and Library)
