#### 1.0 PURPOSE OF REPORT

1.1 The report brings forward proposals for the further allocation of Social Inclusion Partnerships 1 and 2 revenue funding and awards from the Small Grants Fund.

#### 2.0 RECOMMENDATIONS

It is recommended that the Committee:

- 2.1 notes the recommendations of the Dundee Partnership Community Regeneration Group in the further allocation of SIP 1 and SIP 2 revenue funding for 2001/02, as detailed in section 6.2 and Appendix C.
- 2.2 agrees the award of Social Inclusion Partnership 1 Small Grants as detailed in Appendix B.

#### 3.0 FINANCIAL IMPLICATIONS

3.1 The proposed allocation of Social Inclusion Partnership 1 and 2 revenue funding, as detailed in Appendices A, B and C, can be contained within the Social Inclusion Partnership Fund Section of the Neighbourhood Resources and Development Department Revenue Budget 2001/2002.

## 4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 Priority has been given to revenue expenditure that is likely to be of benefit to the environment in the target areas. Also, meeting local needs is a central focus of the strategy for community regeneration and, as such, these measures will impact on numerous Agenda 21 targets.

#### 5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those which fall within the most disadvantaged 10% of enumeration districts at the time of the last Census. The funding made available for the Social Inclusion Partnerships is intended to have the effect of equalling opportunities.

## 6.0 SOCIAL INCLUSION PARTNERSHIPS 1 AND 2 – ALLOCATION OF RESOURCES 2001/2002

# 6.1 Social Inclusion Partnership 1

## 6.1.1 Ann Street Environmental Improvements

A capital funding award of £30,000 was made for the Ann Street Environmental Improvements Initiative from the Social Inclusion Partnership Capital Fund for 2001/2002 (Report 24-2001, NRD Committee 8 January 2001). The total cost of the initiative was estimated at £150,000 the balance of funding anticipated from Planning and Transportation Department's capital budget 2001/2002.

6.1.2 Due to other demands on the Planning and Transportation Department's capital budget allocation, the department has unfortunately not been able to allocate the required matching capital funding of £120,000 to the initiative. In the current financial year the project can only be taken up to design stage, with local consultation on design also being carried out.

6.1.3 The revised phasing of Social Inclusion Partnership capital expenditure will, therefore, be as follows:

The balance of £22,500 is now available for allocation to other Social Inclusion Partnership 1 projects during 2001/2002. Details of proposals for use of this balance and other unallocated funding is given in Section 6.2.

At its meeting of 5 September 2001 the Dundee Partnership Grant Sub Group recommended that £25,000 of the above available funding be transferred to the Social Inclusion Partnership 1 Small Grants Fund.

## 6.3 Social Inclusion Partnership 2 – Revenue Funding 2001/2002

- 6.3.1 The balance of revenue funding available for new initiatives up to 31 March 2002 is £121,130.
- 6.3.2 Further proposals for the allocation of funding within the Social Inclusion Partnership 2 programme are detailed in Appendix C.

## 6.4 SIP 1 SMALL GRANTS FUND (APPENDIX B)

6.4.1 Awards totalling £6,986 are recommended in this report.

## 7.0 CONSULTATION

- 7.1 Consultation has taken place with the Chief Executive, Directors of Finance, Support Services, and Planning and Transportation.
- 7.2 Partnership agencies, associated Council departments, community representatives and voluntary sector representatives have also been consulted and involved in the assessment of applications.
- 7.3 The recommendations are based on targets set by the Scottish Executive Development Department and Dundee Partnership targets. Area regeneration strategies for Kirkton, Ardler, Mid Craigie/Linlathen, and the Hilltown have also been considered prior to the recommendations brought forward in this report. These local area strategies take account of views expressed in a variety of consulting events within local communities.
