#### 1 PURPOSE OF THE REPORT

1.1 This report details future proposals regarding the approach to municipal Bowling Green provision in the city.

#### 2 RECOMMENDATIONS

- 2.1 It is recommended that the bowling greens at Whitfield and South Road Park which have very low usage are closed with effect from 1 April 2018 and that alternative uses are investigated for these assets.
- 2.2 Seek alternative uses of the space at Whitfield and South Road in consultation with the community for the greens affected.
- 2.3 That consultations are held with the clubs operating from the five remaining greens together with the community and key stakeholders regarding a sustainable future of the greens.

#### 3 FINANCIAL IMPLICATIONS

3.1 The closure of the two bowling greens with effect from 1 April 2018 would result in annual revenue savings of approximately £24,000.

#### 4 BACKGROUND

- 4.1 There are currently seven Council managed bowling greens in the city located primarily within public parks. In addition there are a further eleven privately owned facilities. A location plan showing provision of all council and privately bowling greens is provided in appendix 1.
- 4.2 The use of all municipal green in the city has remained low with the green at Whitfield and South Road being particular low. Against an estimated annual cost of maintaining each green of £12,000 excluding the building costs where applicable, the total income for all greens in financial year 2016/17 was approximately £4,000.
- 4.3 Against this background it is recommended that the greens at Whitfield and South Road are closed with effect from 1 April 2018 and that a consultation exercise is held with the community to identify an alternative use for these assets.
- 4.4 The remaining greens have clubs associated with each location. However the income received for each green against the cost of the maintenance still remains disproportionate. It is recognised that the facilities have benefits to the bowling community in terms of health and wellbeing. Hence it is recommended that the Executive Director of Neighbourhood Services is remitted to review the future of these remaining greens and consult with key stakeholders in respect of the future of the greens including consideration of possible community transfers.
- 4.5 Over the last few decades the popularity of bowling as a sport on municipal greens has gradually declined and resulted in a significant underutilisation of the available council facilities.

A number of unsustainable greens have closed in recent few years. However other successful uses for these assets have emerged including:-

- Victoria Park –transferred as a community garden and growing area to Yusuf Youth Initiative (YYI)
- Dudhope Park initially transferred to Dundee Therapy Garden offering garden tuition for former uniformed services. The site has been transformed into a thriving facility which includes raised borders, a large poly tunnel and office facilities to suit all abilities. The charity actively engaged with Dudhope Community and the gardens are open at certain times for the public.
- Fairmuir Park -where one of the greens has now been integrated into the park to form functional community space with seating within a landscaped area which includes fruit trees.
- Baxter Park where in partnership with the Friends of Baxter Park, the space has been transformed and is now a location for a well-used Multi Use Games Area thus ensuring opportunities for sports and physical activity for youths at all levels



## **Document Description:**
