1. PURPOSE OF REPORT

- 1.1 To report progress and seek the Committee's continued approval of the revised strategy produced in partnership by the Single Homeless Strategy Group.
- **1.2** To present the Strategy's updated Action Plan for the period 2000-2002.

2. **RECOMMENDATIONS**

2.1 It is recommended that Committee approves the Single Homeless Housing Strategy and updated Action Plan for 2000-2002.

3. FINANCIAL IMPLICATIONS

There will be no increase in the cost of ongoing funding to projects providing accommodation and support to single homeless people as contained within existing Other Housing budgets.

4. LOCAL AGENDA 21 IMPLICATIONS

4.1 The objectives of the Single Homeless Housing Stragegy are consistent with a number of key Dundee 21 themes; including access to good food, water, shelter and fuel at a reasonable cost; health is protected; access to the skills, knowledge, and information needed to enable everyone to play a full part in society.

5. EQUAL OPPORTUNITY IMPLICATIONS

Participation in the Single Homeless Housing Strategy fulfils the Council's commitment to assist those in need by ensuring that accommodation and care is available for vulnerable people.

6. BACKGROUND

6.1 General

- 6.1.1 The Council's commitment to meeting the needs of single homeless people in Dundee has been evident since 1992, when the Housing Committee adopted "A Five Year Strategy for Accommodation and Support of Single Homeless People", as produced by the Single Homeless Strategy Group (SHSG)
- 6.1.2 Although the original 5 year strategy was revised in 1995, a comprehensive review was carried out between November 1997 and February 1998.
- 6.2 In August 1998, Housing Committee adopted the Dundee Single Homeless Housing Strategy 1998-2001. This new strategy had been developed through a short life working group involving Tayside Health Board, Scottish Homes, Voluntary Agencies with Housing and Social Work Departments.
- 6.2.1 The outcome was a 3 year Action Plan, detailing over 40 projects, designed to reflect the changing circumstances and priorities in the city, and emphasise the benefits of resettlement for single homeless people.
- 6.2.2 Resettlement has been defined as follows: "To secure access for vulnerable homeless people with a history of sleeping rough, to long-terms accommodation which best suits their needs, and to ensure that they do not subsequently lose it or move to less suitable accommodation". G. Randal and S. Brown, DOE 1995.

7. THE DUNDEE SINGLE HOMELESS HOUSING STRATEGY 1998-2001

7.1 The success of the above strategy during 1999-2000, and the developments contained in the Action Plan for 1998-2001 can be seen in the following achievements:

With Rough Sleepers Initiative (RSI) and DSS Capital and Revenue funding secured, construction work started on Dundee Reception and Resettlement Centre.

Dundee Survival Group and the Wishart Centre moved into new premises, providing quality accommodation and services for clients.

NCH Action For Children Dundee Stopover have secured Scottish Homes funding for replacement premises which will increase provision of supported accommodation for 16-21 year olds.

Outreach and Resettlement Service attracted 24 months continuation RSI revenue funding. Since the introduction of this service in 1998, the team have supported 78 hostel clients to move into secure tenancies.

NCH Action For Children, Dundee Supported Living Project secured RSI revenue to assist young Council tenants to sustain their tenancies.

A combination of RSI and CRISIS Smartmove funding was awarded to Dundee's first Rent Deposit Guarantee Scheme. This project will establish

30 tenancies for hostel clients in quality private rented accommodation between 2000-2002.

- 7.2 The future provision of accommodation and resettlement support for single homeless in Dundee will be delivered in a co-ordinated and transparent manner, by continuing the current effective working of the Single Homeless Strategy Group (See Appendix 1).
- **7.3** To review the strategy, the SHSG considered the existing objectives of the strategy in September 2000 and agreed these should remain, as set out below:
 - i to eradicate the need for any person to sleep rough
 - ii to identify and provide outreach services to anyone sleeping rough
 - iii to improve the quality and effectiveness of accommodation and service provision
 - iv to address all the needs of single homeless people, including housing, health, and social needs.
 - v to maximise the opportunity for individuals to achieve independent living through the delivery of resettlement support.
 - vi to pursue initiatives aimed at the reduction and prevention of single homelessness
 - vii to maximise collaboration and effective co-ordination between all agencies offering services to single homeless people and those sleeping rough.
 - **viii** to ensure that the strategy is agreed through ongoing needs assessment, progress review, and performance.
- 7.4 The annual review exercise involved consideration by members of SHSG who remitted the Hostel Sub Group to update the Action Plan to ensure that the objectives are being met, that resettlement services are effective in Dundee, and that the following 5 areas are being addressed: Information and Advice, Assessment, Accommodation, Support Services, and Coordination and Monitoring.
- 7.5 The Action Plan for 2000-2002 (see Appendix 2) describes a clear framework of development activities which will be crucial when accessing alternative sources of funding for single homelessness projects.

7.6 Monitoring the Strategy

7.6.1 The SHSG, led by the Housing Department will continue to monitor progress at its quarterly meetings. The Strategy, reviewed annually, will be completely revised in 2001, as agreed when the strategy was adopted in 1998. Accountability will be sustained through annual progress reports to Housing Committee.

8. CONSULTATION

8.1 The Chief Executive, Director of Finance, Director of Support Services, Director of Social Work, and Chief Corporate Planning Officer have been consulted in the preparation of this report.
