- 6.3 The Leisure and Communities Department is represented on Dundee's Committee for the Care and Protection of Children and Young People (CCPCYP) by the Manager, Children and Young People.
- 6.4 The Department participates fully in the multi-agency self-evaluation process lead by the CCPCYP and using indicators described in Protecting Children and Young People Framework for Standards (2004).
- 6.5 The Department also self-evaluates its Care and Protection policy/practice via the Department's Staff Development and Quality Assurance Team under the overview of the Department's Care and Protection Committee.
- 6.6 The Department ensures that training is undertaken to appropriate levels with all staff in the Department and in line with the multi-agency training programme being developed by the CCPCYP.
- 6.7 Copies of the Leisure & Communities Department Policy and Guidance for the Care and Protection of Children, Young People and Adults at Risk will be placed in the Members Lounge prior to Committee.
