6.0 **BACKGROUND**

- 6.1 The concept of Partnering is an initiative currently promoted as Best Practice by the Government as a means of improving the delivery of service and customer satisfaction in the construction industry.
- 6.2 The Council has now completed a number of contracts using the Partnering Process and is currently processing other contracts on the same basis. The completed projects have been a measurable success and have resulted in savings of cost and time.

7.0 **REPORT**

- 7.1 The works comprise the renewal of felt roofing and a Partnership Contractor was sought to join the Design Team and Client in developing the project together to a mutually agreed timescale and quality within the overall budget of £60,000.
- 7.2 Raynor Roofing Ltd was selected as Partnership Contractor on the basis of their previous satisfactory performance on roofing contracts and are willing to enter into a partnering agreement to carry out these works.
- 7.3 It is recommended that Raynor Roofing Ltd are appointed to carry out these works under a partnering agreement up to a guaranteed maximum price of £51,500 and, if agreed, it will result in the following total costs:-
