1 PURPOSE OF REPORT

1.1 To report on the financial outcome of the Millennium celebrations.

2 **RECOMMENDATIONS**

It is recommended that the Committee:

- 2.1 Note the financial outcome of the Millennium celebrations per Appendix 1.
- 2.2 Consider approval of the uncommitted balance of funds remaining on the Millennium Fund being allocated for Dundee Festival purposes.
- 2.3 If 2.2 above is approved, up to £10,000pa be allocated for Dundee Festival purposes until the Millennium Fund is depleted.

3 FINANCIAL IMPLICATIONS

The City Council's contribution towards Millennium Events totalled £391,229.62 funded by approved contributions of £395,000. Interest earned on the approved contributions made the total funding available £450,071.73. The balance of the Millennium Fund remaining uncommitted amounts to £58,842.11.

4 LOCAL AGENDA 21 IMPLICATIONS

Sustainability was one of the key themes for the programme. Many projects addressed Agenda 21 issues for example the Changing Nature and the Sustainability Projects.

5 EQUAL OPPORTUNITIES IMPLICATIONS

The Millennium programme was intended to ensure that there were opportunities for all sectors of the community to participate in celebrating the Millennium. In addition to universal large scale events, there were a range of targeted events aimed at specific groups including ethnic minorities, young people, the elderly and the disabled. The Community Chest actively encouraged a diverse range of bids from every sector of the community.

6 BACKGROUND

6.1 Millennium Fund

The Policy & Resources Committee approved funding totalling £395,000 as detailed in Appendix 1(1), to fund the City Council's contribution towards the Millennium celebrations. An analysis of the income and expenditure on projects undertaken is provided in Appendix 1(2). The total expenditure amounted to £620,981.85 towards which the Millennium Commission awarded grants totalling £158,795. Sponsorship of £25,780 was received along with other income of £45,177.23. Other income comprised of revenue from ticket sales and departmental project contributions. The balance of expenditure of £391,229.62 was met from the £395,000 of approved Millennium Funding.

Now that the Millennium celebrations are over there remains a balance of funds uncommitted of $\pounds 58,842.11$ being $\pounds 55,071.73$ of interest on sums invested along with a small underspend of $\pounds 3,770.38$ on the City Council's approved contribution.

6.2 Octocentenary Fund

At the conclusion of the City of Dundee District Council's Octocentenary celebrations the Octocentenary Trust was left with a surplus of funds amounting to £44,573.16. The Trustees agreed that the proceeds remaining with the Trust be used to assist the Dundee Festival. The City of Dundee District Council Finance Committee on 21 September 1992 agreed to apply the funds for Dundee Festival purposes with up to £10,000pa being allocated towards the Dundee Festival expenditure recommended by Dundee Festival Trustees, until the fund was depleted.

At present there is an overall balance of funds available to Dundee Festival Trust of only \pounds 1,355.67. This is insufficient funding to maintain continuance of what would be largely the community element of the Dundee Summer Festival in 2002.

6.3 **Proposed Transfer of Millennium Funds**

The funds that remain from the Millennium Fund amounting to £58,842.11 are currently held in the Common Good Account. In view of the decision taken with regard to the surplus Octocentenary funds, the Committee may wish to consider allocating the proceeds remaining from the Millennium Fund towards the Dundee Summer Festival which is administered by the Dundee Festival Trust. If so minded, it is recommended that up to £10,000pa be allocated for Dundee Festival purposes until the Millennium Fund is depleted.

7 CONSULTATIONS

The Directors of Finance, Support Services, Leisure & Arts and Neighbourhood Resources and Development have been consulted in the preparation of this report.
