1.0 PURPOSE OF REPORT

1.1 The purpose of the report is to progress public performance reporting, and to provide the Committee with details of progress achieved through the implementation of Dundee's Social Inclusion Partnerships (SIPS) during 2001/2002.

2.0 RECOMMENDATIONS

The Committee are asked to:

2.1 note progress made in implementing each of the SIPS in Dundee, and the continuing contribution that these programmes make to addressing social justice in the city;

3.0 FINANCIAL IMPLICATIONS

- 3.1 96.08% of the allocated funding was spent during 2001/2002. A breakdown of the SIP funding attracted to Dundee City Council is attached (Appendix 1).
- 3.2 Communities Scotland has approved requests to carry forward unspent monies from 2001/2002 into the current financial year.
- 3.3 SIP1 was approved on a 10-year basis, subject to satisfactory performance. It has now run for 7 years and has a designation which extends to the financial year ending 31 March 2007. The financial allocations to SIP1 are subject to annual Scottish Executive reviews.
- 3.4 SIP2 was formally known as a Regeneration Programme initiative and approved on a 5-year basis. Last year, the Committee were advised of a decision by the Scottish Executive to extend this programme for a further 2 years on a tapering basis. In the current financial year, the financial allocation has been reduced to 75% of last year's level. Next year, the allocation will reduce to 50% of the 2000/2001 funding level.
- 3.5 SIP3 and SIP4 were approved under the 1999 round of SIP bidding and have approved SIP designation until 31 March 2004. Extensions beyond this date have still to be confirmed and will be subject to ministerial guidance on the transition of accountability for SIPS to Community Planning Partnerships.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 SIPS address numerous Agenda 21 targets. In particular, the geographic SIPS aim to benefit the environment of the neighbourhoods on which they are targeted. Meeting needs locally is a central focus for the Geographic SIPS.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the SIP Fund are to be targeted on those geographies which fall within the most disadvantaged 10% of enumeration districts at the time of the last census. The thematic SIPS are also established to address inequality – both are intended to have the effect of equalling opportunities.

6.0 BACKGROUND

- 6.1 It is a condition of the SIP Grant that an annual report be submitted to the Scottish Executive on performance. This report follows on from submission of last year's annual reports and appraisal visits, and highlights key issues arising from the implementation of the SIPS in Dundee.
- Report No 608-2001 details the background to each of the Partnerships and, in the interests of brevity, this report has not repeated detail, but instead focuses on significant changes and headline performance information.

7.0 Social Inclusion Partnership 1 – Ardler/Kirkton/Mid Craigie/Linlathen and the Hilltown

Details of the programmes and projects funded out of the SIP1 budget have been reported to Committee through the year and are summarised in Appendix 2.

- 7.1 During 2002, a review of the Partnership structure was carried out and, in consultation with stakeholders, a new group formed under the auspices of the Dundee (Community Planning) Partnership. This group, which is known as the Geographic SIP Board, has representation from:
 - Dundee City Council (2 places)
 - Scottish Enterprise Tayside (1 place)
 - Private sector (1 place)
 - NHS Tayside (1 place)
 - Community and Voluntary Alliance (2 places)
 - Community representatives (12 places: 3 from each SIP1 community area)
- 7.2 In addition to the above, the Convener of Neighbourhood Resources and Development, and Communities Scotland are ex officio members of the Board.
- 7.3 The new Board held its first meeting in August and has been responsible for bringing forward recommendations on the allocation of resources for the forthcoming financial year and beyond (Report No 862-2002).
- 7.4 The Centre for Planning Research, University of Dundee, continues to be responsible for monitoring and evaluation of the Geographic SIPS in Dundee. In order to take account of the increased levels of reporting requested by the Scottish Executive in the lead up to the end of the SIP2 programme, an additional fixed term appointment to the Unit was approved from SIP funding. This post was filled in November 2002.

8.0 Social Inclusion Partnership 2- Whitfield/Fintry/Mill O'Mains/Charleston/St Mary's etc

Details of the programmes and projects funded out of the SIP2 budget have been reported to Committee throughout the year and are summarised in Appendix 3.

- The main issue facing SIP2 is the wind-down of the programme towards the financial year ending 31 March 2004.
- 8.2 One consequence of the tapered funding is that, prior to the start of the current round of bids, the budget for SIP2 area was more or less fully expended. This is further complicated by the number of applications received for support from both SIP1 and SIP2 budgets.
- 8.3 The level of demand for support for voluntary sector and public sector-led projects in the SIP2 area massively outstrips the availability of resources and there is in excess of £250K worth of project proposals for which there is no funding available at present.

The "Working Together, Learning Together" programme which has provided opportunities for community representatives and lead officers from the SIP2 eligible areas to meet on a bi-monthly basis throughout the year, has provided a valuable platform for discussion relating to regeneration initiatives with SIP2 areas. This group is consulted as stakeholders on the allocation of SIP2 resources.

9.0 Social Inclusion Partnership 3 – Xplore

The Xplore SIP has a thematic citywide focus. Unlike the Geographic SIPS, eligibility for support is not restricted by geography. The aims of this SIP are to provide targeted support for young people between the ages of 11-18 who are deemed to be at risk, and to assist them to make a positive transition from primary to secondary school, or from school to adult life.

9.1 Referrals:

Xplore received 224 referrals from the period June 2001 – May 2002. Of these referrals 76% were male and 24% female.

9.2 The age range for referrals is as follows:

- 9.3 Since Xplore started in January 2000, the age range has shifted down. This does cause some difficulties when dealing with 14-year-old school refusers or those who are exhibiting challenging behaviour in trying to provide a meaningful learning experience that will equip them for adult life. It is often difficult to maintain their motivation until they reach school-leaving age and Xplore is limited by virtue of its funding agreement to a 12-month involvement.
- 9.4 Developments have been made in relation to provision off site for 15 year olds, however, it would be difficult to develop this for 14 year olds given resource constraints and absence of appropriate provision.
- 9.5 The main referral agencies continue to be Education (80) and Social Work (74) representing 69% of all referrals. The next largest referral source is self referrals (18%) showing a steady increase in young people's awareness of Xplore and its services.

9.7 **Programme Progress**

9.7.1 Engagement

This year, 56 referrals related to young people whom for one reason or another had stopped attending school. Reasons included bullying, peer pressure, lack of family encouragement to attend, etc.

Another 83 were referred for behavioural problems such as harming other pupils, causing disruption in class, physical/verbal abuse of teachers.

Xplore counsellors work hard to re-establish links – be it with school, friends or the community as a whole – by providing a one-to-one service tailored to identifying their issues and working together to overcome the barriers. Xplore work with other agencies to develop solutions that the young person finds manageable.

9.7.2 Achievement

Xplore adopts a goal approach. Young people identify personal goals and the support they will need to reach these goals. Last year 163 goals were set of which 74 are ongoing, 49 were achieved, 12 partially met and only and only 27 not met.

9.7.3 *Vulnerability*

Common themes to emerge over the last year are poverty, unstable home life, behavioural or mental health disorders, low self-esteem.

In relation to poverty Xplore have provided financial support to allow young people to access social activities. It is not just the fees alone that are supported but essential equipment and travel costs. Xplore have been successful in securing funding from other organisations such as The Princes Trust to provide a sustained involvement or have negotiated concessions and support from activity providers.

9.7.4 Health

Over the past year Xplore have addressed a range of health issues with young people. This has not just focused on physical health but has included mental well-being, nutrition and sexual health. Last year, the SIP worked with 52 young people who were diagnosed or awaiting clinical assessment for mental health disorders.

118 young people were supported to take part in activities such as blading, gymnastics, cycling, hill walking, outdoor sports etc.

A number of the young people Xplore work with are survivors of sexual abuse. This is often a major contributory factor in their presenting behavioural difficulties. Staff play a supportive role and try to link the young people with appropriate services but there is still a gap in counselling provision for young survivors of abuse.

9.7.5 Self

Xplore have developed 3 personal and social development (PSD) programmes addressing self-esteem, social skills and confidence;

- Belmount Centre Inclusion Partnership Initiative; a 3-day residential course looking at individual needs
- Outdoor Learning Initiative in partnership with Dundee City Council. A combination of group work, initiative exercises and outdoor activities
- Duke of Edinburgh Award specific staff support to involve young people traditionally not participating in the Award

43 young people were involved in these initiatives during the past year.

9.8 The Xplore Partnership remains strong and brings together representatives from all strategic partners working with this target group. The Partnership is developing links with the Working and Learning theme of Dundee's Community Plan.

10.0 Social Inclusion Partnership 4 – Young Carers Partnership

10.1 The Young Carers Partnership in Dundee has been successfully working with partners and young people since 2000. The Partnership's remit is to find hidden young carers and raise awareness of young carers' issues.

- The Young Carers Partnership is one of fourteen thematic SIPS in Scotland. Thematic SIPS have a remit to work with a specific group of people who have particular needs. In the case of Young Carers, this is young people who are caring. Under the Children in Scotland Act, children and young people who help care for a family member are regarded as being "children who are affected by a disability".
- Due to particular family situations, many young people do not want to be identified as young people who are caring; they do not want singled out as different; many are excluded from the normal childhood support networks.
- The Young Carers Partnership is the smallest SIP in Scotland and is uniquely managed, on a day-to-day basis, by the Princess Royal Trust for Carers, a charitable organisation, nationally recognised for its work with carers.

10.5 Staffing

There are currently four full-time members of staff – one co-ordinator, partnership worker, community empowerment development worker, and one administrator/monitoring officer.

10.6 Partners

The Partnership has representatives from:

- NHS Tayside
- Education Department
- Social Work Department
- Neighbourhood Resources and Development Department
- Princess Royal Trust for Carers
- Voluntary sector
- 10.7 Young people who care often do so in isolation. The Young Carers Partnership's aim is to reduce this isolation. The reasons for this exclusion are many but perhaps the overriding experience of young carers if that they do not want to be singled out by their peers for being different.
- However, being a young carer does make you different in many ways. Some young carers do not necessarily see themselves as carers. They assume that what they do is normal and therefore do not expect or ask for help. Many young people who care for family members do not want anyone to know that they have extra responsibilities.
- Young carers have varied responsibilities and deal with situations that many adults would find difficult to cope with. Young people are helping to care for mums and dads, brothers and sisters with severe mental health problems, cancers, HIV/Aids, drugs, alcohol addiction and physical disabilities. They are required to cope with the physical and emotional turmoil associated with caring, attending school and growing up themselves.
- 10.10 Real engagement with young carers in Dundee has taken some time to develop and is only now really coming to fruition.
- 10.11 Up to October 2002, 208 young people have been identified as young carers; the gender ratio is evenly split. 84 currently receive support through befriending, and one to one.
- 10.12 The highest proportion of all referrals/enquiries has come from the voluntary sector, followed by the Education Department.
- 10.13 The majority of young carers in Dundee live in single parent families headed by a mother.

- 10.14 The average age of the identified young carers is 11 years.
- 10.15 The support through Youthcare, the young carers club, continues to be the main source of onward referrals. Young carers, primarily aged 10-14 years, have an opportunity to meet with other young people who care.
- 10.16 The young people involved in the Partnership have engaged with the older Young Carers Group (14-21 years) and the Young Carers' Forum. The Forum is the voice of young carers in Dundee and the hope is that the young people will become more involved through this Forum with carers' issues.
- The Young Carers Partnership has worked with families to deliver a comprehensive training pack, which is unique in Scotland. Other policy developments include development of best practice guidelines for organisations working with young people, which have been endorsed by Dundee City Council, and check lists for the Social Work Department, primarily covering the assessment of young carers, which is now included in the Community Care and Health (Scotland) Act 2002.
- 10.18 The befriending, school placements, one to one and advocacy support available to young carers is essential if young carers in Dundee are to be enabled to achieve inclusion as other children.

11.0 CONSULTATION

- 11.1 The Chief Executive, the Director of Finance and Director of Support Services have been consulted in the preparation of this report.
- The report is based on extracts from annual reports or text submitted by Partnership Co-ordinators.

12.0 BACKGROUND PAPERS

12.1 Each Partnership has submitted an annual report to the Scottish Executive. Copies of these reports have been placed in the Councillors' Lounge. Further copies are available on request. The contents of this report are based on extracts from these annual reports.
