## **1 PURPOSE OF REPORT**

This report details the outcome of engagement by officers of Dundee City Council and Leisure and Culture Dundee with Historic Environment Scotland (HES), Scottish Ministers and other interested parties, over the long-term funding and management of the Broughty Ferry castle, museum, and grounds. The report makes recommendations on the future operation of Broughty castle, museum, and grounds.

## **2 RECOMMENDATIONS**

2.1 It is recommended that Committee agrees to:

- a) continue the current lease arrangement between Dundee City Council and Historic Environment Scotland as set out in para 6.1;
- b) Agree to the installation of floodlighting as set out in para 6.4 and authorise the Executive Director of City Development to award these capital works;
- c) continue to support the operation of the castle, museum and grounds by Leisure and Culture Dundee on a full-time basis;
- d) remit the Chief Executive and Director of Leisure and Culture Dundee to implement all other changes proposed in this report; and
- e) Remit the Director of Leisure and Culture to continue to engage with national and local partners on options to deliver a future sustainable model for Broughty Ferry Castle

## **3 FINANCIAL IMPLICATIONS**

3.1 The approval of the above recommendations would result in the following costs / (savings) for Dundee City Council:

- Maintain revenue funding of £30,000 per annum for property maintenance funded from the existing City Development Revenue Budget;
- Continue revenue funding of £80,000 towards the LACD management fee for the continued operation of the castle, museum and grounds by Leisure and Culture Dundee;
- One-off capital costs of £15,000 for the installation of floodlighting, that will be met in 2025/26 from District Shopping funds that are included within the Built Resilient and Empowered Communities Section of the Capital Plan 2025-30.

## **4 BACKGROUND**

Report 323-2024 of City Governance Committee on 2 December 2024 (Article II – Items ii and iii refers) updated elected members on the results of the consultations on the proposals to change the services provided by Leisure and Culture Dundee (LACD) and made recommendations on changes to be implemented.

4.1 The report proposed that Dundee City Council cease to operate Broughty Castle Museum resulting in it closing at the latest on 31 October 2025. It also recommended that the Council committed to continuing with the investment from the District Centre Fund, which would see the installation of floodlighting at the Castle in 2025.

4.2 The decision of the Committee was to:

- defer a decision on the closure of Broughty Ferry castle, museum and grounds to allow officers of Dundee City Council and Leisure and Culture Dundee to fully engage with Historic Environment Scotland and Scottish Ministers over the long-term funding and management of the castle , museum and grounds and that Officers return to Committee no later than February 2025 with a report detailing the outcome of these discussions and fully engage with any other interested parties regarding the long—term funding and management of the castle, museum and grounds;
- engage with Historic Environment Scotland regarding the future of the Castle and its illumination.

## **5 ENGAGEMENT SUMMARY**

### **5.1 Historic Environment Scotland (HES)**

- 5.1.1 Since the City Governance Committee held on 2 December 2024, a series of meetings have taken place between officers from Leisure and Culture Dundee and Historic Environment Scotland to discuss possible options for the future of the Castle.
- 5.1.2 The Castle is recognised as having key historical significance (remaining as a property in care), however, HES has confirmed that at present there are no planned actions which would provide a like for like operation in place of those that LACD provides. If the current lease agreement with Dundee City Council is terminated HES, would continue to manage the wider scheduled area as well as the external castle building fabric; however, the castle building would not be open to the public on a regular basis.
- 5.1.3 Positive links have been developed between HES, LACD and local voluntary organisations to ensure that all avenues have been explored for different operating models.
- 5.1.4 If the castle, museum, and grounds remain open, there is commitment from HES to work with Leisure and Culture Dundee and Dundee City Council to continue discussions around a longer-term sustainable business model.
- 5.1.5 The Director of Culture and Major Events with Scottish Government has been contacted to ask for consideration into financial support towards the operating costs of the castle museum, and for information on any advancements in the review of the potential to implement a charge to visit museums. Officers await a response from this.

### **5.2 Interested Parties**

- 5.2.1 Officers from Leisure and Culture Dundee have had productive meetings with Broughty Ferry Traders which have resulted in a series of positive marketing campaigns and press articles. This was to inform the level of public appetite for activities focusing on the castle and grounds, delivered in partnership with the Traders.
- 5.2.2 Discussions have been held with local community groups to discuss the potential for the Castle to be operated by volunteers. These included Broughty Ferry Rotary Club and Giving Back Dundee, with links made with HES. A volunteer-led model would require the removal of the museum collection.
- 5.2.3 Engagement has also taken place with representatives from a number of other parties including a Broughty Ferry based Arts organisation, a local tour business and a wellbeing business, who have expressed interest in discussing potential opportunities for delivering events and activities in partnership with Leisure and Culture Dundee if the museum remains open.

- 5.2.4 A national Virtual Reality tourism company based in Dundee and the USA has offered to work with us to develop a visual representation of the history of the castle as an added attraction, providing support in fundraising.

## **6 FUTURE OPERATION OF BROUGHTY CASTLE, MUSEUM AND GROUNDS**

- 6.1 Following the positive discussions with Historic Environment Scotland and the enthusiasm and commitment of a range of interested parties, and the positive public response to the recent focused promotional activities, it is proposed that the lease arrangement with Dundee City Council for the castle, museum and grounds remains in place.

- 6.2 The Castle currently operates the following opening hours:

- Winter Opening Hours from October - March, Tues - Sat 10am - 4pm, Sunday 12.30 - 4pm;
- Summer Opening Hours: April – September, Mon - Sat 10am - 4pm, Sun 12.30 - 4pm

The majority of visits to the Castle take place between April and October, as illustrated in the table below:

- 6.3 The work undertaken since December 2024 has established positive relationships with key partners including HES, Broughty Ferry Traders, and other interested parties, as well as potential funders who are interested in supporting upgrades to the exhibition offer. The media campaign has illustrated the possibilities for engaging with a wider customer base going forward.
- 6.4 Dundee City Council are supporting new tourism focussed developments such as a new coach parking area in Broughty Ferry which would make it easier to attract tours. In addition, following the granting of planning permission in December 2024, and approval from HES, the Council commits to installing replacement floodlighting at the Castle during 2025. The capital cost of the proposed floodlighting is estimated to be £15,000 funded from the District Shopping funds that are included within the Built Resilient and Empowered Communities Section of the Capital Plan 2025-30.
- 6.5 Given the demonstrated interest in supporting the Castle, it is recommended that Broughty Ferry castle, museum and grounds remains open to the public on its existing opening hours model, operated by Leisure and Culture Dundee. Priority will be given to the development of a business plan for the Castle which will identify potential funding streams. This would be reviewed after three years.

## **7 POLICY IMPLICATIONS**

- 7.1 This report has been subject to an Integrated Impact Assessment to identify impacts on Equality & Diversity, Fairness & Poverty, Environment and Corporate Risk. An impact, positive or
