LOCATION

Dundee is Scotland's fourth largest city with an estimated population of 145,000 and a catchment population in the region of 515,000. The city is the regional centre for commerce. Retailing and employment within Tayside, and is located on the east coast of Scotland with 90% of the country's population within 90 minutes' drive time.

The subjects themselves are located on the North side of Main Street close to the junction with Mains Road and the Hilltown, approximately 1 mile north of Dundee City Centre. The subjects are located within a mixed commercial and residential location. On street car parking is available.

The approximate location is shown by the OS Plan.

DESCRIPTION
