## Description

Currently occupied as a Gifts and Contemporary Arts shop which benefit from extensive frontage onto High Street.

The subjects benefit from an open plan sales area to the front with WC and storage to the rear. Natural light is provided by a large display windows. Freshly renovated with modern finish, ready for immediate use for variety of retail uses.

## Location

The subjects are situated in a prominent position in the corner of Castle Street and High Street and within a few minutes walk of Dundee Waterfront.

Neighbouring occupiers include Costa, Slaters Menswear, Greggs. The subjects also benefit from being in very close proximity to both the Overgate and Wellgate Shopping Centres.


