Letter from Murray Webster, representing the Coldside Community Forum:

9/6/2025

Hello Jennifer

I am writing to you to submit my apologises for the Coldside Local Community Planning Partnership meeting due to take place on Tuesday 10<sup>th</sup> June 2025. I would ask that this letter is presented to the meeting.

I feel it would make me a hypocrite to attend this meeting as it will be discussing setting out the priorities for the new planned merged LCPP for Coldside and Maryfield. I strongly disagree with the way this merger has been undertaken, first off, no consultation with the two communities that will be impacted by this change. Then when we asked questions, we were told that there was no time to carry out consultation and even when we were asked our views, they were met with little understanding of our concern by senior Dundee City Council staff or elected members. It was said that it was regrettable that we were not consulted but this was the best way forward to ensure widest possible engagement with other partners.

The communities concern that the reduction in Community Officer posts from 1.5 to 1 has been brushed aside as an operational issue. I still can't understand why if the posts currently require 1.5 staff that the same amount of work can be done with 1 post.

I am concerned that the number of meetings going forward will now reduce from 8 across the 2 Wards to 4. This will mean less time to discuss matters that relate to each ward and could see a reduction in the voice of the community due to the numbers of meeting being reduced.

I would like to express my thanks for your efforts whilst you have been in post as Community Officer for the Coldside Ward, you have helped ensure that local people in Coldside have had the opportunity to have their voice heard, you have supported local groups to achieve a great deal for our communities though help securing funding and helping them communicate their work and services to the whole Ward though Coldside Connections and other media.

You have also dealt with all the fallout from this decision in a truly professional manner and have been a great support to me and others as we have tried to deal with the impacts of this decision.

I wish you every success going forward and note you will be a loss to Coldside. I hope that the opportunity to work with you in the future happens.

Update from – Police Scotland

What Needs to Change	What we are doing.
There needs to be improved life chances for children and families in Coldside	<ol> <li>Youth Engagement – Police Scotland have been working with partners including CLD (Community Learning and Development) workers, DCC ASBT Youth Workers and SFRS to develop youth engagement and awareness raising opportunities.</li> </ol>
There needs to be better support for people in recovery and their families in Coldside	<ol> <li>Drug Harm/ Mental Health – Police Scotland continue to focus on a collaborative approach to these issues, applying the 4 D's model of divert / deter / disrupt and detect, whilst also signposting to relevant support agencies for persons in contact with Police Scotland in these circumstances, mitigating risk and further incidents.</li> </ol>
	2. Ditch the Dealer – Police Scotland remain committed to acting on community intelligence in respect of drug dealing activities and there has been several drugs search warrants executed across Coldside during this quarter with positive results. Community Officers deliver Ditch the Dealer leaflets to surrounding properties where a Drugs Search Warrants have been executed to provide reassurance to neighbours and ensure they have the correct details for reporting issues to Police/Local Authority. Further, if intelligence is received that there is drug dealing activity at a specific address, but there is insufficient intelligence to obtain a Drugs Search Warrant, PSYV and Community Safety Wardens are tasked with delivering these to surrounding properties to build the intelligence picture with a view to progressing to a warrant application.
There needs to be better support for young people who have	1. Crime incident and reviews – All crime and ASB incidents are reviewed daily, with emerging trends quickly identified and solutions found, whether that be Police led, or signposting to the most appropriate agency. Police Scotland remain focused on driving a multi-agency response to anti-social behaviour and have worked closely with partners in DCC during this quarter,

sharing information in line with information sharing protocols. One example being the multi-agency response to a female regularly breaching an anti-social behaviour order implemented to protect other tenants, including those young people who have their own tenancy. Understanding roles and responsibilities, Downfield CPT worked with ASBT to gather evidence and put the female to Court on multiple charges, allowing Dundee City Council to utilise their legislative powers to instigate eviction proceedings for the female's tenancy. As part of this process, an engagement session was carried out with tenants to provide re-assurance, improve their understanding of the procedures involved in these types of enquiries and to sign post to support services. This was well received and has been replicated in similar cases across Coldside.

2. Police Scotland are committed to keeping people safe and continue to provide awareness inputs and training to partners who have regular interaction with young people who have their own tenancies. This is to ensure professionals recognise the signs of criminal sexual exploitation, county lines and cuckooing and know how to approach these matters. This extends to the Partners Intelligence Portal, which is a secure and confidential electronic system, developed by the Police Service to enable partner agencies to share important information they receive during their work. This portal provides partners with the means to securely and discreetly submit key information, whilst maintaining safeguards which protect the source of the information and does not replace current incident or crime reporting methods. The portal can be used for any form of intelligence where there is no immediate risk to an individual with recent examples including ASB and drugs.

The following work is also ongoing in Coldside -

#### **Fearless Campaign**

St. Johns High School will be piloting / delivering the Fearless campaign in Dundee, which incudes -

- Ongoing peer support approach to the delivery of No Knives Better Lives (NKBL) supported by Police Scotland Youth Volunteers.
- The Fearless material / services are the main resource used to raise awareness around knife crime and are
  not exclusive to schools given the reach being designed for young people across local communities, with
  proposed pilots being developed for local consideration.

#### Safe Taysider's Dundee

As part of the transition process from Primary to High School Police Scotland are working with DCC ASBT, SFRS, RNLI, NHS and Education to deliver a format called Safe Taysiders which will be delivered to Primary 7 pupils at all schools across Dundee, raising awareness around various matters including fire raising, water safety, drugs, violence and e-motorbikes.

#### **Designing Out Crime Officer**

Police Scotland, Tayside Division, have a specialist officer who works closely with Planning, Architects and builders etc where a new development (Housing/Commercial/Education etc) is being built. The DOCO liaises with same to ensure opportunities for both Acquisitive Crime and Crimes of Violence, also Violence Against Woman (in public) are reduced as much as possible. Further, where a problem issue/area is identified, the DOCO can be tasked with carrying out an Environmental Scan, thereafter, liaising with various agencies to

ensure the opportunities to commit Crime and ASB are greatly reduced. The DOCO has been involved in efforts to prevent ongoing anti-social behaviour and fire-raisings at the old Caldrum Works, which DCC have taken responsibility for securing.

#### **FRASB Group**

Due to an increase in secondary fires across the city, including in Coldside, Police Scotland have been contributing to the fire related anti-social behaviour group (FRASB), set up to identify, monitor and action emerging trends. This also ensures a structured and consistent approach from agencies when dealing with prevention and investigation of secondary fires.
