



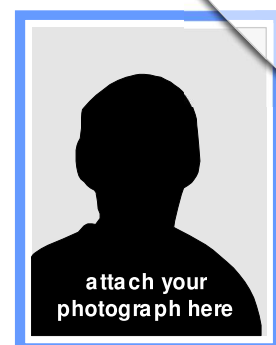

PHOTO GUIDANCE

You must supply a recent photograph for your card. Your photograph should be a recent colour close-up of your head and shoulders and be a good likeness. Your features should be clearly distinguishable against the background. Please do not wear a hat or head covering (unless for religious reasons), or wear a hood up, or wear dark glasses as all of these make it difficult to tell if it is you in the photo and we **CANNOT ACCEPT IT**.

The photo should be 45mm x 35mm, in sharp focus, and printed on plain white photo quality paper.

Because you can use your Card for many Council services and Young Scot Proof of Age if applicable, we have to verify that the photograph you give is actually of you. **If you can provide a Passport, Photo Driving Licence or a PASS hologrammed Young Scot card and the photo is recognisable as you, you do not need the Referee's declaration completed.**

Otherwise, please ask someone who knows you, who is **NOT** a relative or part of your family, is over 25 years old and in a full time, professional job (like a teacher, doctor, nurse, community worker, social worker, police officer or religious leader) to write on the back of your photograph:

I confirm that this is a true likeness of [full name of applicant] and sign and date the back of the photo.

They must then complete and sign the declaration.
