#### **Dundee City Council**

#### **Environment and Safety Information Act 1988**

#### **Public Register of Health and Safety Enforcement Notices**

The Act requires a register to be maintained of Notices served under Sections 21 and 22 of the Health and Safety at Work etc. Act 1974 i.e. Improvement and Prohibition Notices.

Details required to be held in a public register are those that could affect members of the public. Notices that impose requirements or prohibitions solely for the protection of persons at work are exempted.

Each entry in the register states sufficient particulars to convey the substance of the notice to which it relates.

Entries in the register shall be made:

- a) where there is no right of appeal, 14 days after the notice is served; or
- b) where there is a right of appeal but no appeal is brought within the time limit for doing so, 14 days following the day on which the time so limited expires; or
- c) where there is such a right and an appeal is brought, 14 days following the day on which the appeal is finally disposed of.

When the notice has been complied with, this will be entered in the register within 7 days of determining compliance.

Entries in the register which relate to a notice will be kept in the register for a period of not less than five years from the date on which the notice was served. Entries where the notice has not been complied with will remain on the register indefinitely.
