**DUNDEE CITY COUNCIL (BALLUMBIE ROAD AREA, DUNDEE)  
(20 MPH ZONE) ORDER 2021**

Dundee City Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4(1) and (2) and 84 of the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the said Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as "Dundee City Council (Ballumbie Road Area, Dundee) (20 mph Zone) Order 2021" and shall come into force on the Twenty Third day of December Two Thousand and Twenty One.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour in or upon any of the lengths of road specified the Schedule to this Order.

SIGNED at DUNDEE on the SEVENTEENTH day of DECEMBER TWO THOUSAND AND TWENTY ONE.

**BALLUMBIE RISE AVENUE** for its entire length, a distance of 47 metres or thereby.


**BALLUMBIE RISE GARDENS** for its entire length, a distance of 396 metres or thereby.

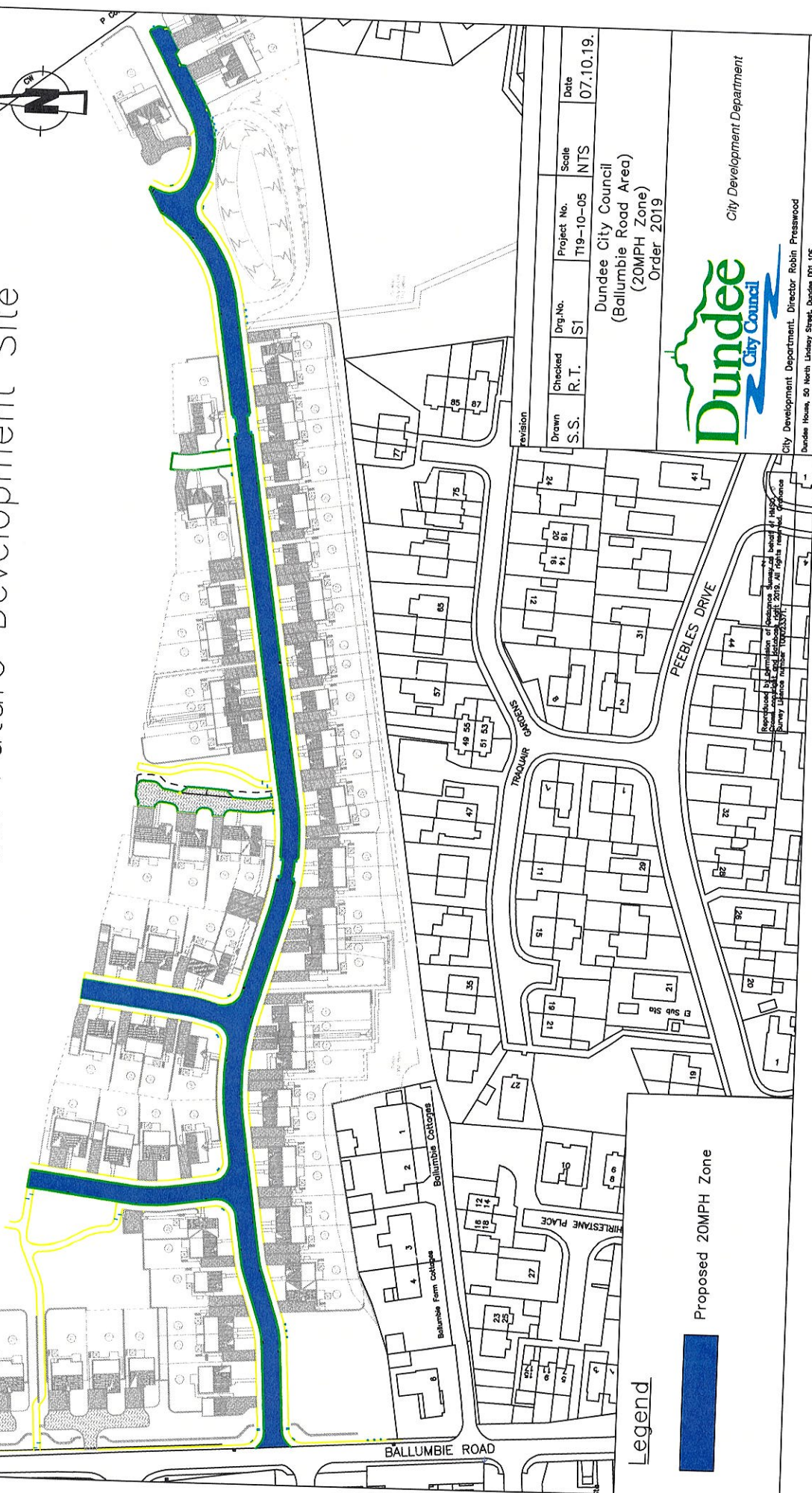
