Progress on site



As we now enter autumn, Mclaughlin & Harvey continue to make good progress on Flood Protection Scheme and remain on schedule for completion of the project early 2022.

Works on the Douglas Terrace and James Place have been completed and are open to the public, whilst the works are progressing further along Fisher Street.



You will have noticed that the Fort Street junction is currently closed to traffic– this will be for approx. 6 weeks, to allow the construction of the RNLI car

park, the new Promenade footway to the south and the reconstruction of the carriageway. The completion of these works will take us a step closer to the next section of street works into Beach Crescent.

Works are already progressing on the beach at Beach Crescent with the installation of large concrete steps which will transform the area and provide an open access down to the pebble beach. It will offer a great area for the public to relax and enjoy the view! Works will be ongoing in this

area over the next few months with progress of the stepped revetment construction visible on a weekly basis.
