<u>DUNDEE CITY COUNCIL (CHARLESTON AREA, DUNDEE) (STOPPING-UP)</u> ORDER 2021

Dundee City Council, in exercise of the powers conferred upon them by Section 208 of the Town and Country Planning (Scotland) Act 1997 and of all other powers enabling them in that behalf, being satisfied that it is necessary to authorise the stopping up of the footpaths hereinafter specified in the Order to enable development to be carried out in accordance with planning permission granted under Part III of that Act hereby make the following Order:-

- This Order may be cited as "Dundee City Council (Charleston Area, Dundee) (Stopping-Up) Order 2021 and shall come into operation on the date when confirmation of the order is advertised.
- 2. In this Order, "footpaths" means the length of public streets in the City of Dundee, which are specified in the Schedule to this Order.
- 3. The stopping-up of footpaths is hereby authorised.
- 4. Where, immediately before the date of this Order, there are any rights of statutory undertakers in respect of any apparatus which is under, in, on, over, along or across the lengths of roads, footpaths and footways such undertakers shall thereafter, without prejudice to the provisions of Section 224 of the Town and Country Planning (Scotland) Act 1997, have the same rights in respect of that apparatus as they had immediately before that date.

Schedule

Areas of Footpaths to be Stopped Up.

The footpaths situated within the Charleston area of Dundee shown hatched black on the 4 attached Plans with Reference T20-10-02 and numbered S1, S2, S3 and S4 will be stopped up as follows:

BALGARTHNO ROAD TO GOURDIE TERRACE

From the north heel line of Balgarthno Road to the southeast edge of carriageway of Gourdie Terrace distance of 36.5 metres or thereby.

INVERCRAIG PLACE TO CHARLESTON ROAD FOOTPATH

From the north heel line of Invercraig Place to the west heel line of Charleston Road, a distance of 60 metres or thereby.

BALGARTHNO ROAD TO GOURDIE PLACE (ALL LEGS)

From their junctions with the north heel line of Balgarthno Road to the junction with the south heel line of Gourdie Place, a combined distance of 116 metres or thereby.


BUTTAR'S ROAD (FOOTPATH NORTH OF NO 32 BUTTAR'S ROAD)


For its entire length, a distance of 52.5 metres or thereby.


BUTTAR'S ROAD (FOOTPATH NORTH OF NO 26 BUTTAR'S PLACE)


For its entire length, a distance of 60 metres or thereby.
