DUNDEE CITY COUNCIL (CRAIGIE STREET AND ELIZA STREET, DUNDEE) (PROHIBITION OF DRIVING AND VARIATION OF WAITING RESTRICTIONS) ORDER 2022

Dundee City Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) and 121A and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the said Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order may be cited as Dundee City Council (Craigie Street and Eliza Street, Dundee) (Prohibition of Driving and Variation of Waiting Restrictions) Order 2022 and shall come into operation on the Thirty First day of November Two Thousand and Twenty Two.
- The Council are satisfied that for preventing the likelihood of danger arising to persons or other traffic using the restricted roads, it is requisite that Section 3(1) of the Road Traffic Regulation Act 1984 should not apply in relation to this Order.
- 3. Subject to Article 3 hereof no person shall drive or cause or permit to be driven any vehicle in or upon the lengths of roads as specified in the attached Schedule.
- 4. Nothing in Article 2 of this Order shall apply for Police, Fire Brigade or Ambulance purposes and for Leisure and Culture Dundee maintenance vehicles.
- 5. The Orders specified in the Schedule hereto are further varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.

From a point 53 metres or thereby westwards from its junction with Kemback Street westwards to the end of carriageway, a distance of 28 metres or thereby.






