



# Dundee City Council Community Empowerment Report

2019/20



## Purpose

A report to meet Dundee City Council's requirements under ss.32 and 95 of the Community Empowerment Act (Scotland) 2015 to produce an Annual Report on Participation Requests and Community Asset Transfer.

For both Participation Requests and Community Asset Transfers triggered under the Act we report a nil return.

Please see Appendix 1 for a full breakdown of the information required under s. 32 of the Act. Please see Appendix 2 for a full breakdown of the information required under s.95 of the Act.

Although Dundee City Council reports a nil return for completed Asset Transfers under the Act we are at an advanced stage in completing one Community Asset Transfer under our voluntary scheme.

Dundee City Council refused 2 Participation Requests due to the requests being invalid, Dundee City Council offered to engage with both groups in a process similar to an Outcome Improvement Process. One group agreed to this.

## Promotion

Under ss.32 (d)(i) and 95 (f)(i) of the Act we are required to outline what steps we have taken to promote Participation Requests and Community Asset Transfer respectively.

We have a dedicated webpage on our website where citizens can find out about Community Empowerment

This includes an e-learning module which promotes and explains to citizens how they can make these requests and the benefit to them of doing so.

An internal audit carried out by KPMG recommended that the materials available to the community to support Community Asset Transfer are updated and this will be carried out by August 2020. The Asset Register has been reviewed and going forward will be reviewed on an annual basis. We will also use the opportunity to update supporting materials for Participation Requests.



# Support

Under ss.32 (d)(ii) and 95 (f)(ii) of the Act we are required to outline what steps we have taken to support groups and individuals through the process of undertaking Participation Requests and Community Asset Transfer respectively.

The DCC CLD Service was reconfigured in March 2020 to merge our Community Regeneration and Community Based Adult Learning teams into a single Community Empowerment Team.

Going forward this team will have targets to proactively use CAT and Community Right to Buy to support community groups in Dundee and to help them deliver on their aims and objectives.

To this end 18 CLD Workers in Dundee were given training from our Community Ownership Support Service link worker in order to enable them to support community groups to work towards these aims.

The Community Empowerment Team will be expected to proactively use the powers from the Community Empowerment Act to support communities to achieve their goals.
