Improve connectivity from the Central Waterfront new public green and blue spaces to The Law- <ul style="list-style-type: none"> <li>• Plant green corridors and street trees along route between the Law and the Waterfront e.g. along Marketgait and Constitution Road (in front of old college building).</li> <li>• Signage and waymarking city centre to The Law.</li> </ul> </li> <li>2. Established Greenways and core paths provide connectivity.	<ol style="list-style-type: none"> <li>1. Development of the Regional Performance Centre within Caird Park offers an opportunity to improve accessibility/connectivity to the park.</li> <li>2. Protect and maintain locally important nature conservation sites (LINC's) along Dundee Road West/East Dock Street/Broughty Ferry Road and strengthen the nature conservation interest of this link around Dundee Port.</li> <li>3. Additional street trees along Pitkerro Road - fill in gaps.</li> <li>4. Access aspirational community cycle routes across Kingsway.</li> <li>5. Consult internal Green Flag Action Plans for opportunities within Baxter, Stobsmuir and Finlathen Parks and Eastern Cemetery.</li> </ol>
<b>(f) Dawson Link</b>	Existing green assets including Claypotts Park and Dawson Park provide 'stepping stones' between green network assets in the north (The Dighty) and green assets along the Tay Corridor Green Network.	<ol style="list-style-type: none"> <li>1. Consult internal Green Flag Action Plan for opportunities within Dawson Park.</li> <li>2. Formalise access link between Dighty down to Arbroath Road/Strathern Road continuing to Grassy Beach/Stannergate, taking in Dundee/Angus College.</li> </ol>
