## 1. Introduction

This profile report is for the East End Local Community Planning Partnership (LCPP)/Ward and its community areas. The report presents statistical information from the 2020 Scottish Index of Multiple Deprivation (SIMD).

The SIMD is the Scottish Governments official tool for identifying places in Scotland suffering from deprivation. The 2020 SIMD was originally published on 28<sup>th</sup> January 2020. After identifying an error data used to compile the SIMD, the Scottish Government published a revised version of the 2020 SIMD in June 2020.





This document reports on the SIMD 2020 data published in June 2020. Where available, data is broken down to community areas within LCPP/Wards to allow differences within each community area to be highlighted.



The Scottish Index of Multiple Deprivation (SIMD) is the Scottish Governments official tool for identifying places in Scotland suffering from deprivation. Deprivation in this context refers to the range of problems that arise due to the lack of resources or opportunities covering health, safety, education, employment, housing, access to services and financial aspects.

- Scotland is split into 6,976 small areas, called 'data zones', with roughly equal population.
- The Scottish Government look at indicators to measure the different sides of deprivation in each data zone, like pupil performance, travel times to the GP, crime, unemployment and many others.
- These 38 indicators of deprivation were grouped into 7 types, called 'domains'.
- The 7 domains are combined into one SIMD, ranking each data zone in Scotland from 1 (most deprived) to 6,976 (least deprived).
- Focusing on small areas shows the different issues there are in each neighbourhood. These could be poor housing conditions, a lack of skills or good education, or poor public transport.

The community areas used in this profile document are geographical areas that were developed by Dundee City Council, Neighbourhood Services and they split Dundee City into 54 geographical areas. The raw data used to populate this profile is only produced at data zone level. Data zones are much larger geographical areas than the community areas meaning that one data zone can be split across multiple community areas or LCPP/Wards. To analyse and display the data at community area level, work is undertaken to proportion out the data zones to assign the relevant parts that fall within each community area and LCPP/Ward.

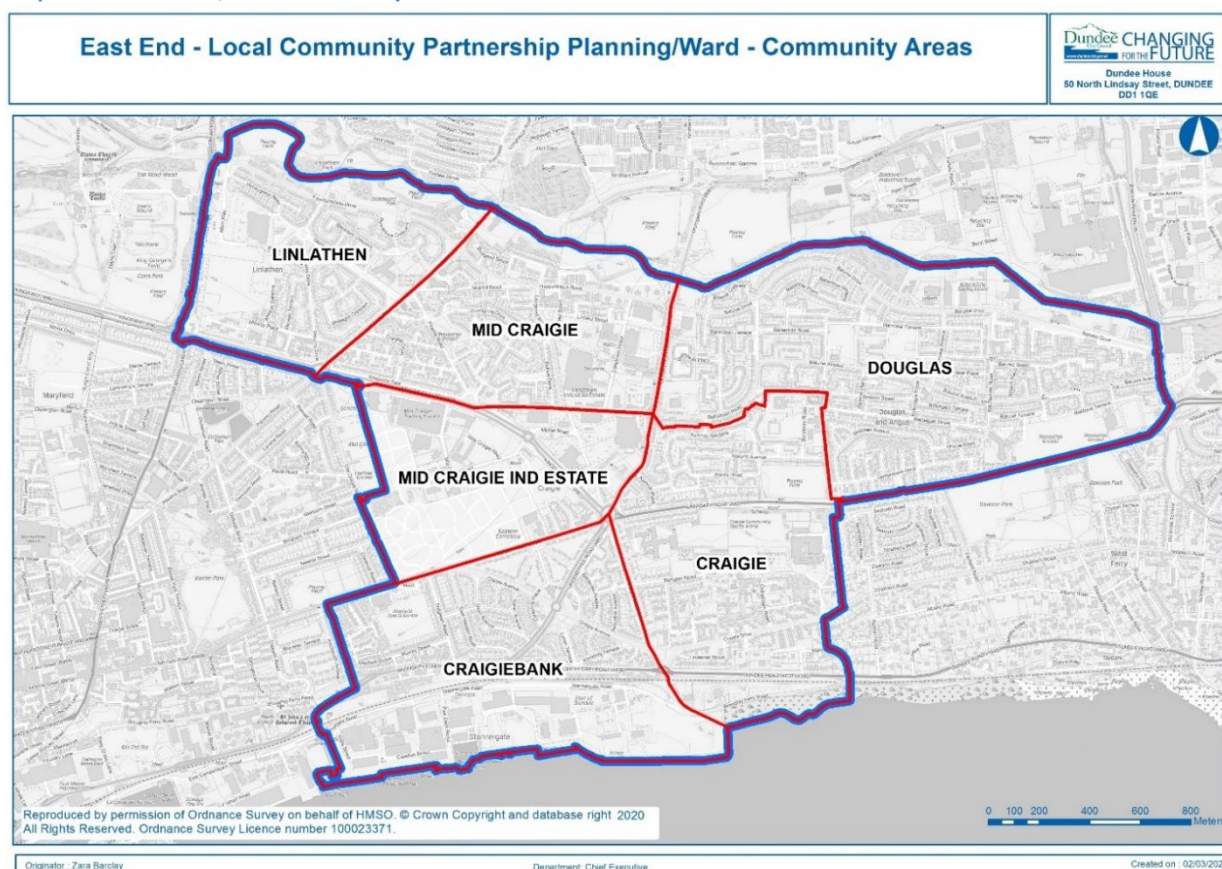

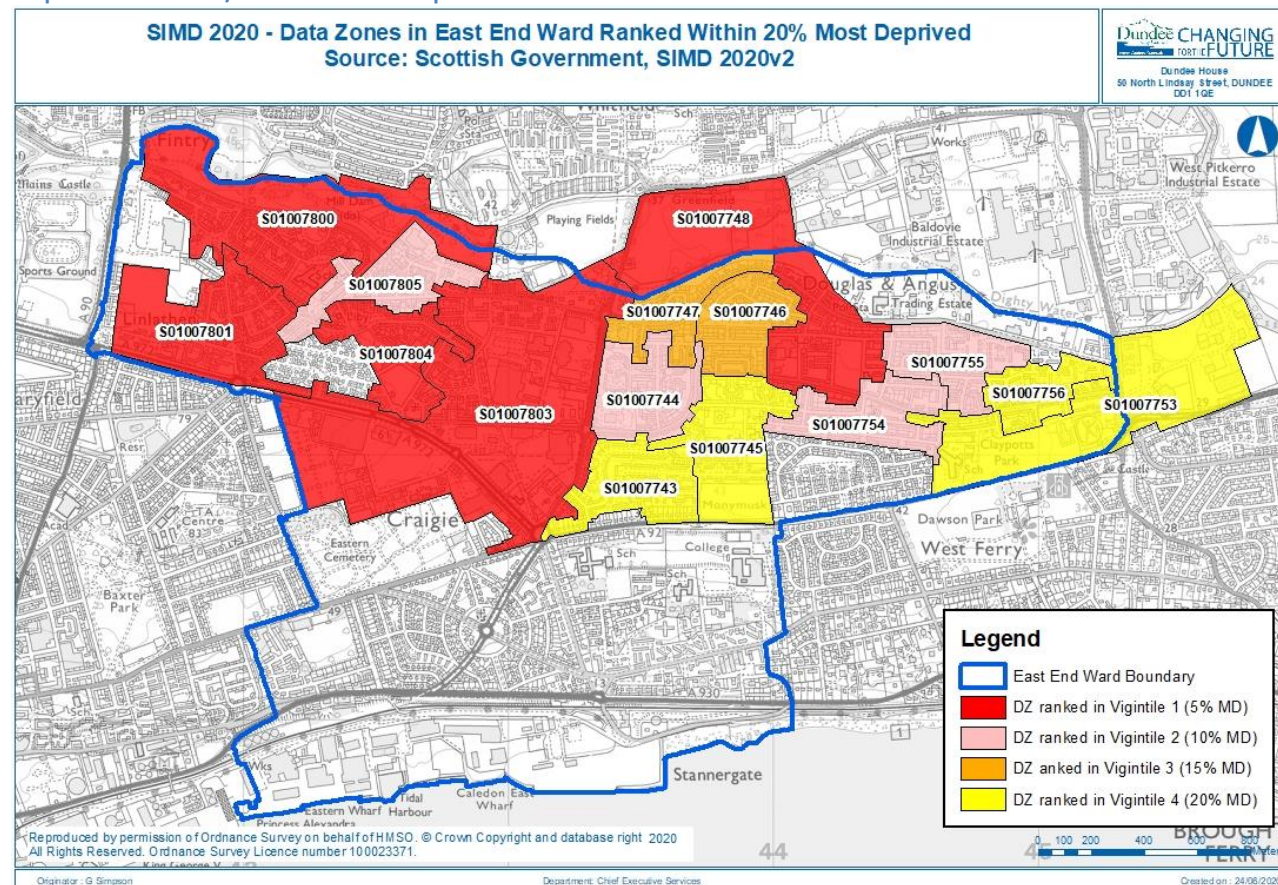

### 3. East End LCPP/Ward – Data Zones Ranked in the 20% Most Deprived

**Map 2** shows the location of the data zones in East End LCPP/Ward that are ranked in the 20% most deprived data zones in Scotland as reported in the SIMD 2020.

The above map shows that within East End LCPP/ Ward there are **15 data zones** ranked within the 20% most deprived in the SIMD 2020.

In the SIMD 2016, there were 14 data zones within East End LCPP/ Ward ranked in the 20% most deprived, this has increased to 15 in the SIMD 2020. The number of data zones ranked in the 20% most deprived also increased for Dundee City overall from 69 in the SIMD 2016 to 70 in SIMD 2020.

## 4. Percentage of the population who live in the 5% and 20% Most Deprived Data Zones

**Table 3** shows the percentage of the population in each community area who live in a data zone ranked in the 5% and 20% most deprived in the SIMD 2020. It should be noted that the percentage of the population who live in the 5% most deprived data zones will also be counted within the percentage of the population who live in the 20% most deprived data zones.

Around 90% of the population who live in the Linlathen live in a data zone ranked in the 5% most deprived in the SIMD 2020, this is the highest proportion of all community areas contained within the East End LCPP/Ward. Mid Craigie (62.7%) also has a high percentage of its population living in data zones ranked in the 5% most deprived. Mid Craigie Industrial Estate (35.9%), Douglas (10.9%) and Craigie (3.8%) also have a proportion of their respective populations living in data zones ranked in the 5% most deprived. Craigiebank is the only community area in the East End LCPP/Ward that does not have any of its population living data zones ranked in the 5% most deprived.

The percentage of the population living in data zones ranked in the 20% most deprived varies across community areas in the East End LCPP/Ward. Linlathen (92.6%), Douglas (88.0%) and Mid Craigie (79.7%) are the community areas that have the greatest proportions of their populations living in data zones ranked in the 20% most deprived. Craigiebank was the only community area within East End LCPP/Ward where 0% of the population lived in a data zone ranked in the 20% most deprived.

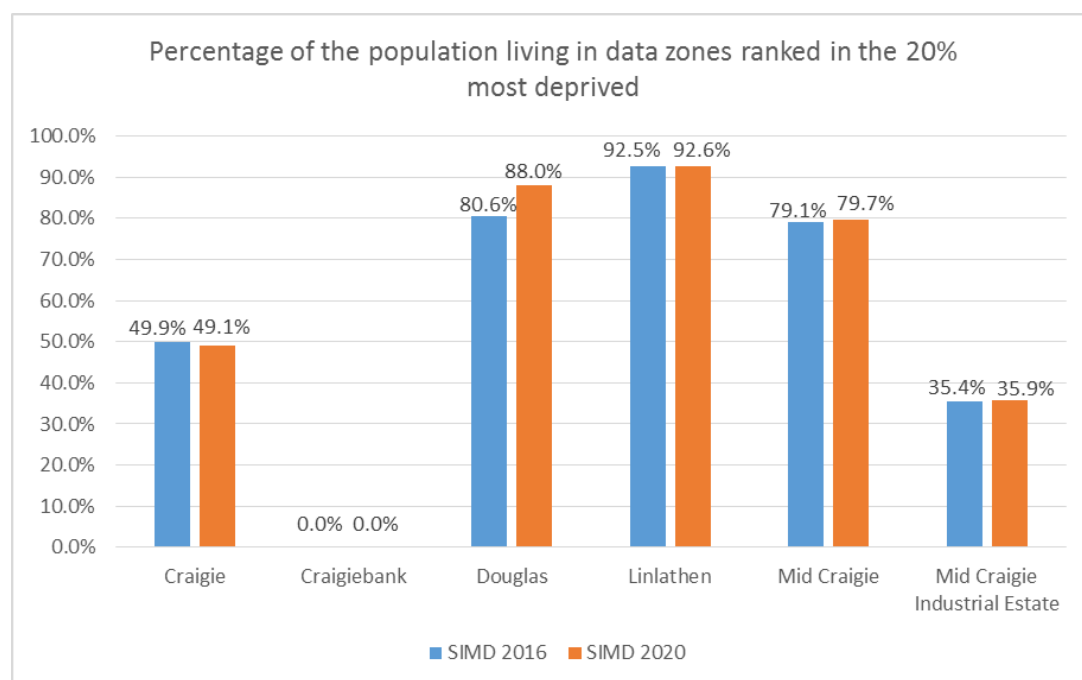

Douglas, Linlathen, Mid Craigie and Mid Craigie Industrial Estate experienced an increase in the percentage of the population living in data zones ranked in the 20% most deprived when comparing the 2016 and 2020 SIMD. The greatest increase occurred in Douglas where the percentage of the population living in these data zones increased from 80.6% in 2016 to 88.0% in 2020. There was a slight decrease in Craigie from 49.9% in 2016 to 49.1% in 2020. In Craigiebank 0% of the population lived in a data zone ranked in the 20% most deprived in both the 2016 and 2020 SIMD.

**Table 5** shows the percentage of children aged 0-15 years in each of the community areas who live in a data zone ranked in the 5% and 20% most deprived in the SIMD 2020. It should be noted that the percentage of children (0-15yrs) who live in the 5% most deprived data zones will also be counted within the percentage of children (0-15yrs) who live in the 20% most deprived data zones.

The above table shows that 91.2% of children (aged 0-15 years) who live in Linlathen live in a data zone ranked in the 5% most deprived, this is the highest proportion when compared to the other community areas in East End LCPP/Ward. Over 60% of the population aged 0-15yrs in Mid Craigie and Mid Craigie Industrial Estate also live in a

data zone ranked in the 5% most deprived. In contrast just under 6% of children aged 0-15 years in Craigie live in a data zone ranked in the 5% most deprived. Craigiebank is the only community area in East End LCPP/ Ward where no children aged 0-15 years live in a data zone ranked in the 5% most deprived.

With the exception of Craigiebank, all other community areas within the East End LCPP/Ward have a proportion of their child population (those aged 0-15yrs) living in a data zone ranked within the 20% most deprived. The proportion of children living in these data zones varies in the community areas from over 90% in Douglas and Linlathen to around 54% in Craigie.

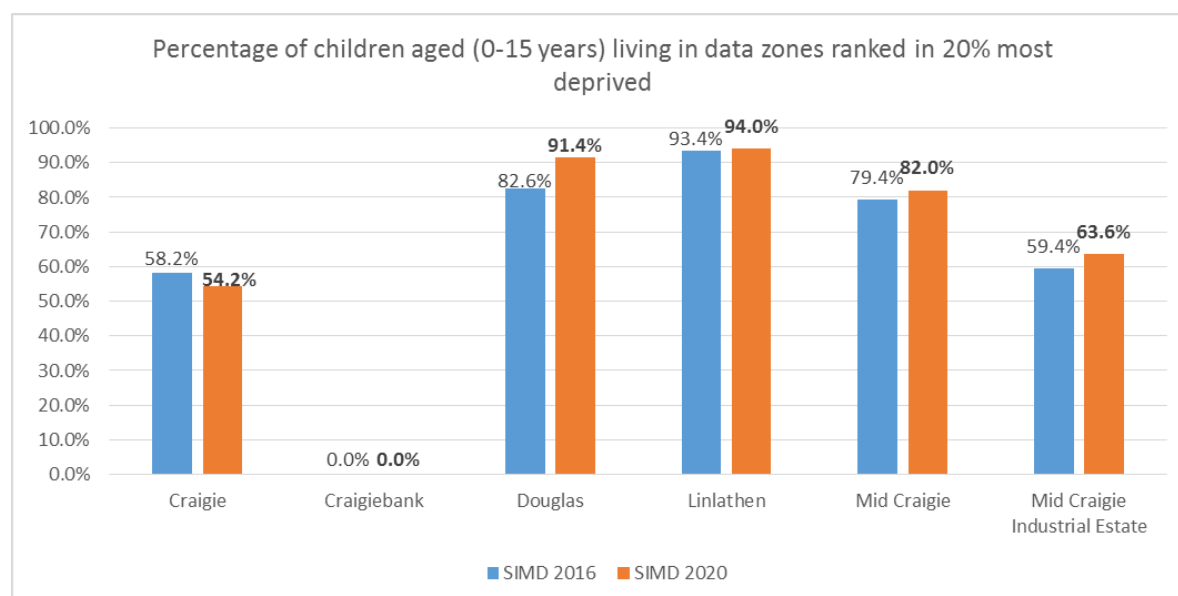

The above chart looks at the percentage of children (0-15yrs) who live in data zones ranked in the 20% most deprived in the 2016 and 2020 SIMD. Douglas, Linlathen, Mid Craigie and Mid Craigie Industrial Estate all experienced increases in the proportion of children living in data zones ranked in the 20% most deprived, however the scale of the increase varied across the community area. The greatest increase occurred in Douglas from 82.6% in 2016 to 91.4% in 2020. Craigie was the only community area to experience a decrease from 58.2% in 2016 to 54.2% in 2020. In both the 2016 and 2020 SIMD no children (0-15years) in Craigiebank lived in a data zone ranked in the 20% most deprived.



## 5. Health Domain

The health domain in the SIMD examines rates of mortality, hospital stays related to alcohol and drug misuse, illness, prescription rates for certain conditions and low birth weights. **Table 7** shows the percentage of the population in each East End LCPP/Ward community area that live in a data zone ranked within the 20% most deprived in the health domain as reported in the SIMD 2016 and 2020.

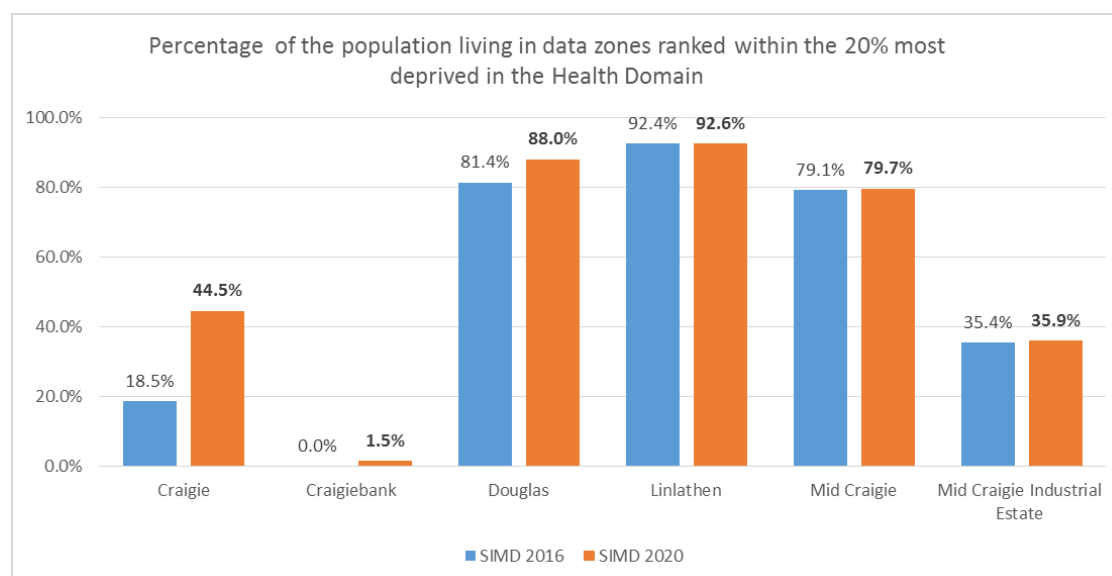
The percentage of the population who live in data zones ranked in the 20% most deprived in the health domain varies across community areas. When looking at the 2020 SIMD data, the majority of those in Linlathen (92.6%), Douglas (88.0%) and Mid Craigie (79.7%) live in a data zone ranked in the 20% most deprived in the health domain. In contrast the percentage stands at 1.5% in Craigiebank. At an overall East End LCPP/Ward level 70.9% of the population live in a data zone ranked within the 20% most deprived in the health domain, this is higher than the overall Dundee City percentage which stands at 36.6%.

All community areas experienced an increase in the percentage of the population living in data zones ranked in the 20% most deprived in the health domain. The levels of increase varied across the community areas with the greatest increase occurring in Craigie from 18.5% in 2016 to 44.5% in 2020. At East End LCPP/Ward level the percentage of the population living in data zones ranked in the 20% most deprived in the health domain increased from 62.9% in 2016 to 70.9% in 2020. There was also an increase at Dundee City level from 33.5% in 2016 to 36.6% in 2020.

## 6. Education Domain

The education domain in the Scottish Index of Multiple Deprivation examines school absences, pupil performance, working age population with no qualifications, FE/HE education rates and unemployed youths (16-19) not in full time education, employment or training. **Table 8** shows the percentage of children (aged 0-15 years) in each East End LCPP/Ward community area that live in a data zone ranked within the 20% most deprived within the education domain.

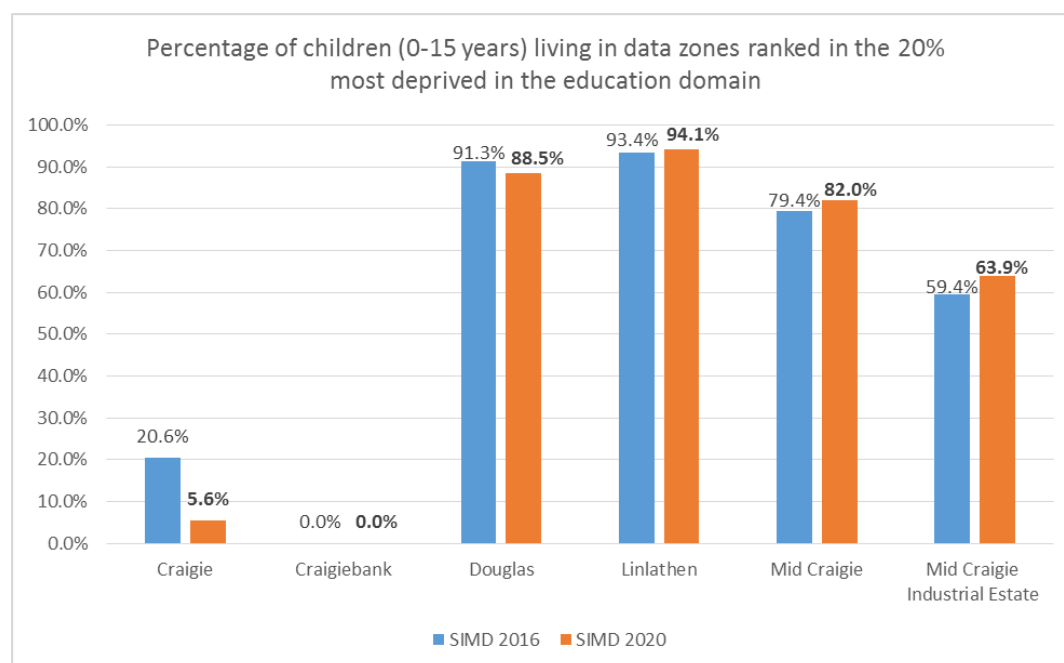
The 2020 SIMD reported that the majority of children aged 0-15 years in Linlathen (94.1%), Douglas (88.5%), Mid Craigie (82.0%) and Mid Craigie Industrial Estate (63.9%) live in a data zone ranked within the 20% most deprived in the education domain. The percentage is much lower in Craigie where it stands at 5.6%. Craigiebank is the only community area within the East End LCPP/Ward where 0% of children aged 0-15 years live in a data zone ranked within the 20% most deprived in the education domain. At East End LCPP/Ward level 71.7% of children aged 0-15 years live in a data zone ranked in the 20% most deprived in the education domain, this is higher than the overall Dundee City proportion which stands at 47.3%.

When comparing the percentage of children (aged 0-15 years) living in data zones ranked in the 20% most deprived within the education domain in the SIMD 2016 and 2020, Linlathen, Mid Craigie and Mid Craigie Industrial Estate all experienced increases. The greatest increase occurred in Mid Craigie Industrial Estate from 59.4% in 2016 to 63.9% in 2020. Decreases however occurred in Craigie and Douglas, with Craigie experiencing the greatest decrease from 20.6% in 2016 to 5.6% in 2020. Craigiebank was the only community area within East End LCPP/Ward where 0% of children (0-15 yrs) lived in a data zone ranked in the 20% most deprived in the education domain in both the 2016 and 2020 SIMD.

Overall in East End LCPP/Ward the percentage of children (0-15 years) living in data zones ranked within the 20% most deprived in the education domain decreased from 74.1% in 2016 to 71.7% in 2020. There was however an increase at Dundee City level from 45.0% in 2016 to 47.3% in 2020.

## 7. Employment Deprivation

The employment domain in the Scottish Index of Multiple Deprivation examines unemployment claimant counts averaged over 12 months, working age incapacity benefit or employment support allowance recipients and working age severe disablement allowance recipients.

**Table 9** shows the percentage of the working age population in each community area within East End LCPP/Ward who live in a data zone ranked in the 20% most deprived in the employment domain as reported in the 2016 and 2020 SIMD.

The 2020 SIMD shows the majority of the working age population in Linlathen (88.8%), Douglas (80.1%), Craigie (75.9%) and Mid Craigie (60.8%) live in data zones ranked in the 20% most deprived in the employment domain. A lower proportion of the working age population in Mid Craigie Industrial Estate (39.0%) and Craigiebank (1.3%) live in data zones ranked in the 20% most deprived in the employment domain.

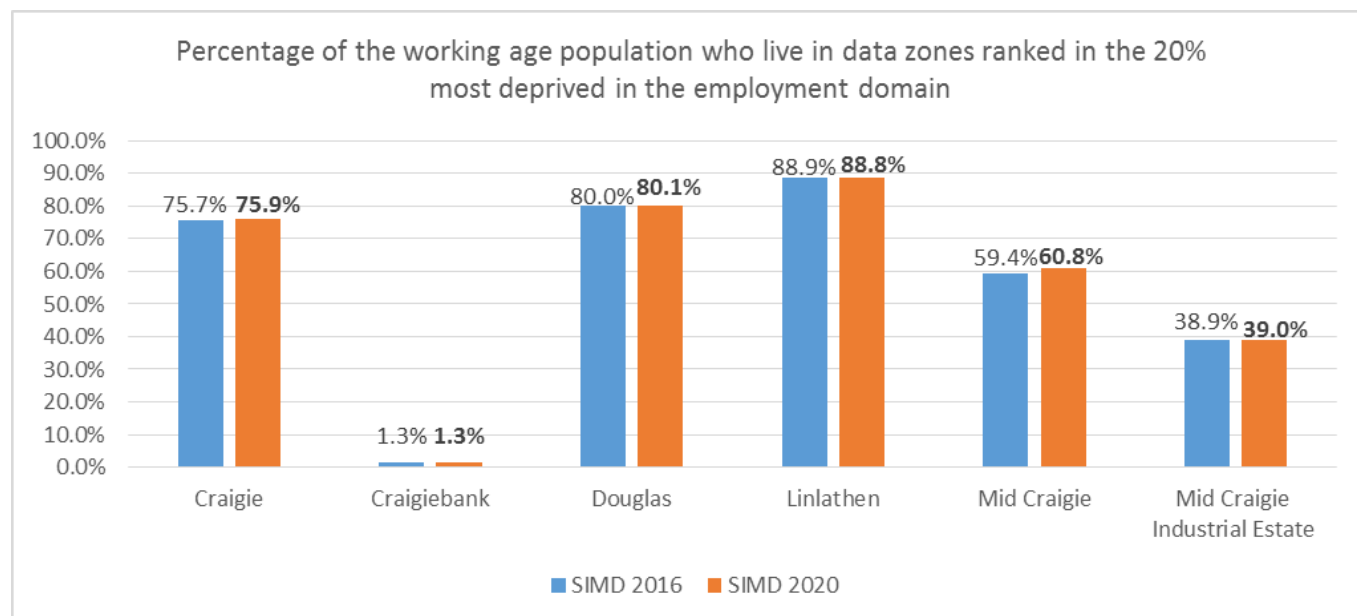
Overall at East End LCPP/Ward level, 69.6% of the working age population live in a data zone ranked in the 20% most deprived in the employment domain, this is higher than the Dundee City proportion which stands at 36.4%.

When comparing the SIMD 2016 and 2020, Craigie, Douglas, Mid Craigie and Mid Craigie Industrial Estate all experienced very slight increases in the percentage of the working age population who live in data zones ranked in the 20% most deprived in the employment domain. A very slight decrease occurred in Linlathen, and the percentage of the working age population in Craigiebank living in data zones ranked in the 20% most deprived in the employment domain remained at the same level in both the 2016 and 2020 SIMD.

At East End LCPP/Ward level around 70% of the working age population in both the SIMD 2016 and 2020 lived in data zones ranked in the 20% most deprived in the employment domain. There was very little change at Dundee City level from 36.9% in 2016 to 36.4% in 2020.

The Scottish Index of Multiple Deprivation also provides a count of the number of employment deprived people in each data zone. The number of employment deprived people is a useful measure as it can show the number of individuals who are classed as being employment deprived in data zones that are not ranked in the 20% most deprived. **Table 10** shows the percentage of the working age population who are classed as employment deprived in the SIMD 2016 and 2020.

The 2020 SIMD reported that 26% of the working age population living in Linlathen are classed as employment deprived, this is the highest level of all the community areas within East End LCPP/Ward. Craigiebank is the community area within East End LCPP/Ward that has the lowest proportion at 10.3%. Overall in East End LCPP/Ward 18.1% of the working age population are classed as employment deprived this is higher than the overall Dundee City percentage which stands at 12.4%.

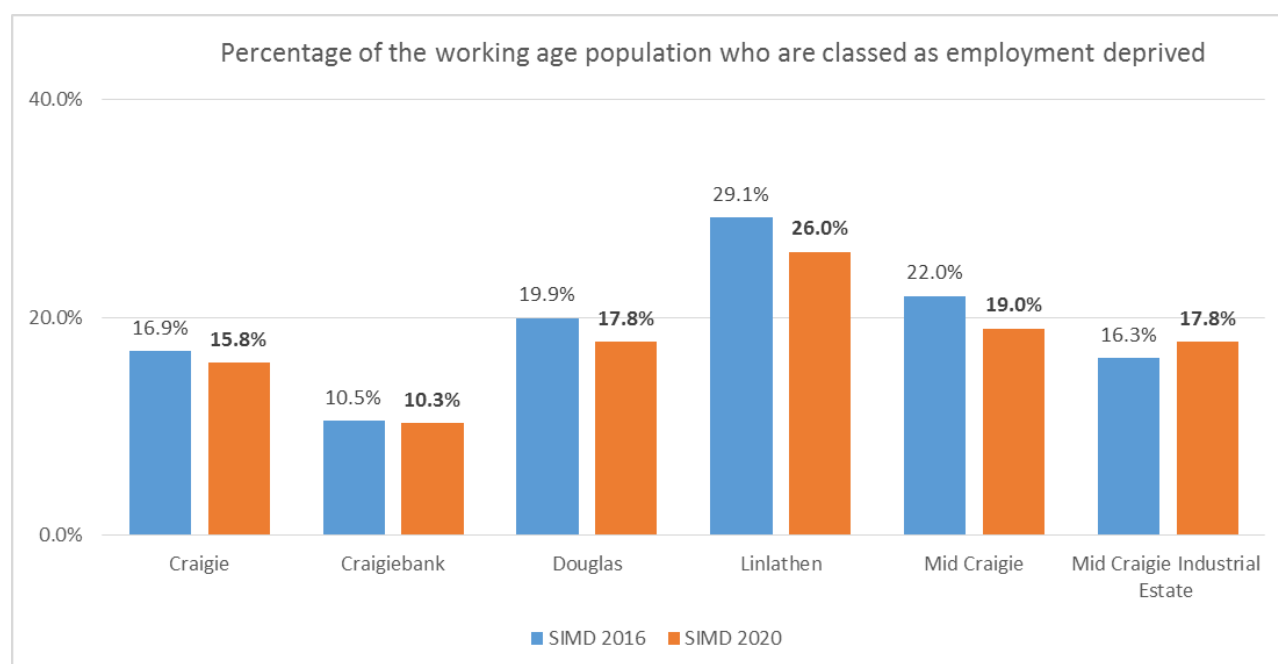

When comparing the SIMD 2016 and 2020, Mid Craigie Industrial Estate is the only community area within East End LCPP/Ward that experienced an increase in the percentage of the working age population classed as employment deprived. The remaining community areas experienced a decrease, with decreases of around 3% occurring in Linlathen and Mid Craigie.

Overall in East End LCPP/Ward, the percentage of the working age population classed as employment deprived decreased from 20.2% in 2016 to 18.1% in 2020. There was also a decrease at Dundee City level from 14.1% in 2016 to 12.4% in 2020.

## 8. Income Domain

The income domain in the Scottish Index of Multiple Deprivation examines adults and children in Income Support or Income-based Employment Support Allowance households, adults in Guarantee Pension Credit households, adults and children in Job Seekers Allowance households and adults and children in Tax Credit families. **Table 11** shows the percentage of the population in each community area within East End LCPP/Ward who live in a data zone ranked in the 20% most deprived in the income domain as reported in the 2016 and 2020 SIMD.

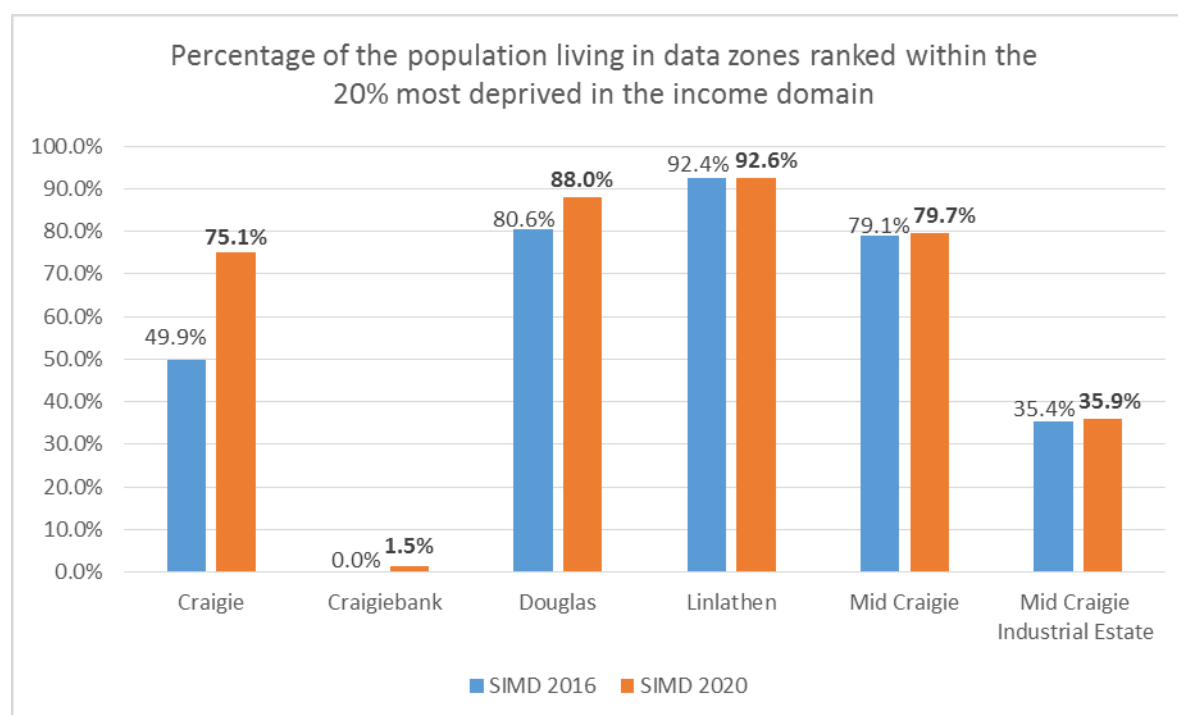
The 2020 SIMD shows that the majority of the population who live in Linlathen (92.6%), Douglas (88.0%), Mid Craigie (79.7%) and Craigie (75.1%) live in a data zone ranked in the 20% most deprived in the income domain. In contrast 1.5% of the population in Craigiebank live in a data zone that is ranked in the 20% most deprived in the income domain. At an overall East End LCPP/Ward level 76.3% of the population live in a data zone that is ranked in the 20% most deprived in the income domain, this is higher than the Dundee City percentage which stands at 36.6%

When comparing the 2016 and 2020 SIMD, all community areas in the East End LCPP/Ward experienced an increase in the percentage of the population who live in data zones ranked in the 20% most deprived in the income domain. Craigie was the community area which experienced the greatest increase from 49.9% in 2016 to 75.1% in 2020.

Overall at East End LCPP/Ward level the percentage of the population living in data zones ranked in the 20% most deprived in the income domain increased from 68.2% in 2016 to 76.3% in 2020. There was also an increase at Dundee City level from 35.7% in 2016 to 36.6% in 2020.

**Table 12** shows the proportion of the population who are income deprived in each community area as reported in the 2016 and 2020 SIMD. The number of income deprived people is an attempt to identify individuals who are income deprived despite not living in a data zone that is ranked within the 20% most deprived.

The SIMD 2020 reported, Linlathen with 35.4% is the community area within East End LCPP/Ward which has the greatest proportion of the population who are classed as income deprived. In contrast 12.3% of the population in Craigiebank are classed as income deprived. At overall East End LCPP/Ward level 25.3% of the population are classed as income deprived this is greater than the Dundee City level which stands at 16.4%.

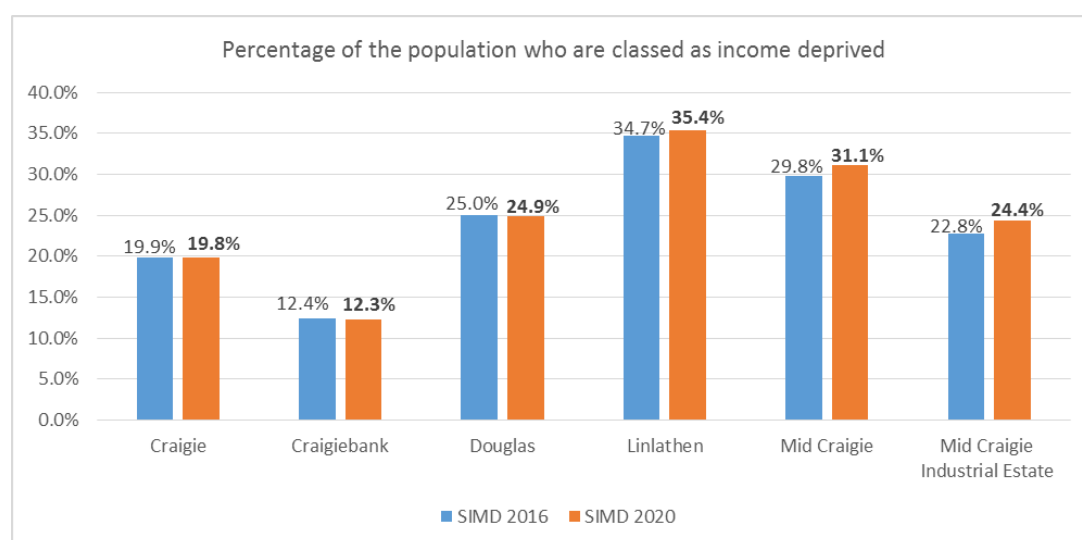

When comparing the 2016 and 2020 SIMD decreases in the percentage of the population classed as income deprived were experienced in Craigie, Craigiebank and Douglas. In contrast increases were experienced in Linlathen, Mid Craigie and Mid Craigie Industrial Estate. Overall in East End LCPP/Ward the percentage of the population who were classed as income deprived increased very slightly from 25.0% in 2016 to 25.3% in 2020. The percentage remained at 16.4% at Dundee City level.

## 9. Housing Domain

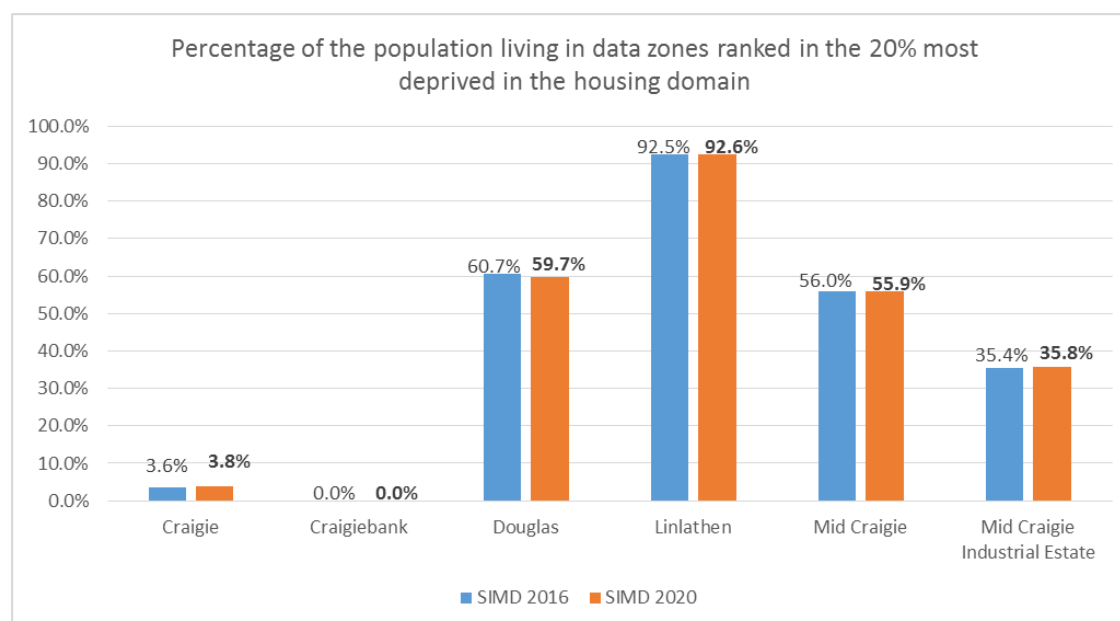
The housing domain in the Scottish Index of Multiple Deprivation focusses on households that are over-crowded and persons in households without central heating. **Table 13** shows that according to the SIMD 2020, 92.6% of the population in Linlathen live in a data zone ranked in the 20% most deprived in the housing domain. In contrast the percentage stands at 3.8% in Craigie. Craigiebank is the only community area within East End LCPP/Ward where 0% of the population live in a data zone ranked in the 20% most deprived in the housing domain. Overall 47.5% of the population in East End LCPP/Ward live in a data zone ranked in the 20% most deprived in the housing domain this is slightly lower than the Dundee City percentage which stands at 45.5%.

There is little change in the percentage of the population in each community area living in data zones ranked in the 20% most deprived in the housing domain when comparing the 2016 and 2020 SIMD. Very small increases of less than 1% occurred in the Craigie, Linlathen and Mid Craigie Industrial Estate. Small decreases did however occur in Douglas and Mid Craigie. Overall in East End LCPP/Ward the percentage of the population living in data zones ranked in the 20% most deprived in the housing domain stood at 47.5% in both the SIMD 2016 and 2020. At Dundee City level the percentage increased slightly from 45.3% in SIMD 2016 to 45.5% in 2020.

## 10. Crime Domain

**Table 14** shows the percentage of the population in each East End LCPP/Ward community area that live in a data zone ranked within the 20% most deprived in the crime domain as reported in the 2016 and 2020 SIMD. The SIMD crime domain does not include all types of crime or offence recorded by the police. Certain crimes have been excluded because of data quality issues, or because they are less meaningful in terms of deprivation at a neighbourhood level.

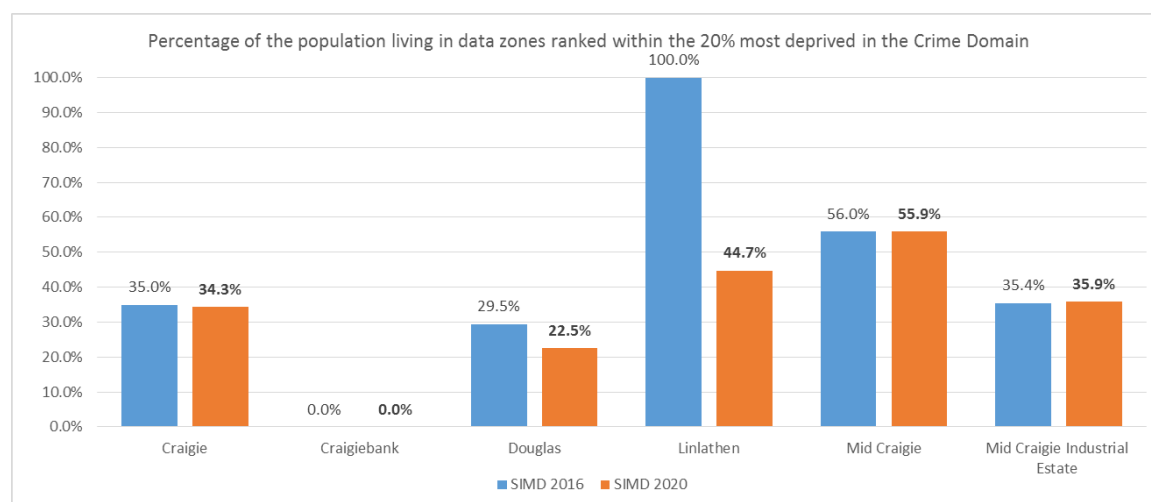
The SIMD 2020 reported that 55.9% of the population living in Mid Craigie live in a data zone ranked within the 20% most deprived in the crime domain. In contrast the percentage stands at 0% in Craigiebank. At an overall East End LCPP/Ward level, 30.9% of the population live in a data zone ranked in the 20% most deprived in the crime domain, this is higher than the overall Dundee City proportion which stands at 33.1%.

When comparing the 2016 and 2020 SIMD, Craigie, Douglas, Linlathen and Mid Craigie all experienced decreases in the percentage of the population living in data zones ranked in the 20% most deprived in the crime domain. Linlathen experienced the greatest decrease from 100% in 2016 to 44.7% in 2020. There was a slight increase in Mid Craigie Industrial Estate from 35.4% in 2016 to 35.9% in 2020. The percentage stood at 0% in Craigiebank in both SIMD publications. There was a decrease at East End LCPP/Ward level from 40.0% in 2016 to 30.9% in 2020. In contrast there was an increase at Dundee City level from 30.9% in 2016 to 33.1% in 2020.
