# <u>DUNDEE CITY COUNCIL (MENZIESHILL COMMUNITY CENTRE AND ORLEANS PLACE AND SHORE TERRACE CAR PARKS) ORDER 2021</u>

Dundee City Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 32, 35 and 121A and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the said Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order may be cited as Dundee City Council (Menzieshill Community Centre and Orleans Place and Shore Terrace Car Parks) Order 2021 and shall come into operation on the Twenty Sixth day of April Two Thousand and Twenty One.
- 2. The Orders specified in the Schedule hereto are further varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.

### In The Dundee City Council (Off-Street Car Parks) Order 1996

#### In Part III of the Order

In Article 20

After Article 20 (2) (v), add and insert

- "(vi) a vehicle left in a parking space in the Menzieshill Community Centre Car Park and bearing the livery of Leisure and Culture Dundee
- (vii) a vehicle left in a parking space in the Orleans Place Car Park displaying a valid a residents' parking permit, issued and defined n terms of the Dundee City Council (Menzieshill Area, Dundee) (Controlled Parking Zone – Residents Permit Scheme) Order 2003

#### In Part IV of the Order

#### In Article 46B

In line 2, after the words "Car Parks", add and insert

"(other than the Menzieshill Community Centre Car Park)

After Article 46B, add and insert

"46B(1)

No person shall cause or permit a vehicle to wait in a car parking space in the Menzieshill Community Centre Car Park during peak hours for a period longer than four hours."

#### In Article 46D

In line 1, after the words "Car Park", add and insert

"(other than the Menzieshill Community Centre Car Park)

After Article 46D, add and insert

"46D(1)

No vehicle which has been taken away from a parking space in the Menzieshill Community Centre Car Park during peak hours shall, until the expiration of twelve hours from the time it was taken away, be left again in that car park during peak hours."

After PART V, add and insert:-

#### "PART VI

#### **USE OF ORLEANS PLACE CAR PARK**

- 51. The following articles shall apply to the Orleans Place Car Parks only and except where the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:-
  - "Charge Free Period" means maximum period or length of time for which a person is permitted to leave a vehicle in a parking space in Orleans Place Car Park during

Operational Hours without payment of a charge in accordance with Columns 6 and 7 of Paragraph (iC) of Part 1 of the Schedule;

"ticket" means a ticket or tickets issued by a ticket issuing machine relating to Orleans Car Park;

"ticket issuing machine" means apparatus designed to indicate the time by a clock and to issue numbered tickets:

"Operational Hours" means 8 am to  $\mathfrak 3$  pm Monday to Saturday and 1pm to 6pm on Sundays.

#### 52. Display of Tickets

No person shall cause or permit a vehicle to wait in a car parking space in Orleans Place Car Park during Operational Hours without obtaining a ticket from a ticket issuing machine and exhibiting it in the relevant position.

#### 53. Indications by Tickets

- a) Where the ticket issued is in respect of a Charge Free Period, each ticket will indicate the indicate either (a) the day and expiry time of the Charge Free Period in respect of which a ticket has been issued or (b) the day and expiry time of the Charge Free Period, together with the identification mark of the machine from which the ticket has been issued.
- b) Payment of a charge for a vehicle left in the Orleans Place Car Park shall be indicated by the issue by a ticket issuing machine of a numbered ticket relating to the car park in which the vehicle is left indicating either the day and time of payment of the charge or the day and expiry time of the period purchased and by the exhibition of that ticket on the vehicle in accordance with the provisions of Article 7(5) of this Order.
- c) The expiry of the period for which a charge has been paid in Orleans Place Car Park shall be indicated when there is exhibited on the vehicle a ticket issued in terms of paragraph (b) hereof and the clock on the ticket issuing machine from which the said ticket was issued shows a time which indicates that a period in excess of the said period has elapsed.

### 54. Limitation on Charge Free Periods During Peak Hours

- a) If a vehicle has been left in Orleans Place Car Park for a charge free period, then following the expiry of that charge free period the vehicle must be removed from Orleans Place Car Park and no person shall be entitled to pay a charge for an additional period of parking beyond the charge free period.
- b) Notwithstanding the terms of Article 15, no person, having removed a vehicle from Orleans Place Car Park upor the expiry of a charge free period shall cause or permit the same vehicle to be left again in Orleans Place Car Park until after the expiry of the Operational Hours for that day.
- c) If a vehicle has been left in Orleans Place Car Park for a period in respect of which a charge has been paid, then the person who has paid that charge shall be entitled, in accordance with Article 7(4) to pay an additional charge in for an additional period.


