### **DUNDEE CITY COUNCIL (MILL O' MAINS, DUNDEE) (STOPPING-UP) ORDER 2024**

Dundee City Council, in exercise of the powers conferred upon them by Sections 207 and 208 of the Town and Country Planning (Scotland) Act 1997 and of all other powers enabling them in that behalf, being satisfied that it is necessary to authorise the stopping up of the roads, footpaths, footways and parking areas hereinafter specified in the Order to enable development to be carried out in accordance with planning permission granted under Part III of that Act hereby make the following Order:-

- This Order may be cited as "Dundee City Council (Mill O' Mains, Dundee) (Stopping-Up)
  Order 2024 and shall come into operation on the date when confirmation of the order is
  advertised.
- 2. In this Order, "roads, footpaths, footways and parking areas" means the length of public streets in the City of Dundee, which are specified in the Schedule to this Order.
- 3. The stopping-up of roads footpaths, footways and parking areas is hereby authorised.
- 4. Where, immediately before the date of this Order, there are any rights of statutory undertakers in respect of any apparatus which is under, in, on, over, along or across the lengths of roads, footpaths and footways such undertakers shall thereafter, without prejudice to the provisions of Section 224 of the Town and Country Planning (Scotland) Act 1997, have the same rights in respect of that apparatus as they had immediately before that date.




For their entire lengths.
