DUNDEE CITY COUNCIL (VARIATION OF WAITING RESTRICTIONS) ORDER 2023

Dundee City Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4(1) and (2), 32 and 121A and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the said Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as "Dundee City Council (Variation of Waiting Restrictions) Order 2023" and shall come into operation on the Ninth day of October Two Thousand and Twenty Three.
- 2. The Orders specified in the Schedule hereto are further varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.
